RESOLUTION 2023-812

A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF MICHAEL T. FACKLER AS THE GENERAL COUNSEL PURSUANT TO SECTION 7.03 OF THE CHARTER OF THE OF JACKSONVILLE; DIRECTING LEGISLATIVE SERVICES TO NOTIFY THE CLERK OF COURT, PROPERTY APPRAISER, SHERIFF, SUPERVISOR OF ELECTIONS, TAX COLLECTOR AND CHAIRPERSON OF THE DUVAL COUNTY UPON SCHOOL BOARD INTRODUCTION OF THIS RESOLUTION TO ENCOURAGE INPUT AND GUIDANCE REGARDING THIS APPOINTMENT PURSUANT TO COUNCIL RULE 4.1103; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the selection of the General Counsel is governed by Section 7.03 (Selection and Term of the General Counsel) of the City of Jacksonville Charter; and

WHEREAS, in accordance therewith, at the commencement of newly elected Mayor Donna Deegan's term, Mayor Deegan empaneled the General Counsel's Qualification Review Committee, comprised of five attorneys consisting of the Jacksonville Bar Association President, two former general counsels and two members of the Florida Bar Board of Governors; and

WHEREAS, Mayor Deegan subsequently appointed an acting General Counsel to serve for a period of 90 days beginning July 1, 2023 and expiring at the end of September, 2023, in order for there to be continuity of management and orderly operation in the Office of General Counsel during the pendency of the deliberations of the General Counsel's Qualification Review Committee; and

WHEREAS, upon expiration of the initial acting General Counsel's term, Mayor Deegan appointed Michael T. Fackler as acting General Counsel for a 90-day period beginning September 29, 2023, to allow for continued orderly operation in the Office of General Counsel until the Qualifications Review Committee could convene to review Mr. Fackler's qualifications and make a recommendation; and

WHEREAS, the 90-day period for Mr. Fackler's term as acting General Counsel will expire at the end of December, 2023; and

WHEREAS, on October 26, 2023, the General Counsel's Qualification Review Committee convened and voted unanimously to strongly recommend Michael T. Fackler be appointed as General Counsel; and

WHEREAS, Mr. Fackler graduated with High Honors from the University of Florida Levin College of Law in 2002 and began the practice of law as a Law Clerk for the Honorable Harvey E. Schlesinger of the United States Middle District of Florida; during that time he also served as an Adjunct Professor at Florida Coastal School of Law, teaching legal research and writing and appellate advocacy; since 2004, Mr. Fackler has focused his practice in the area of complex commercial litigation, most recently as a partner with the established local law firm of Milam Howard Nicandri & Gillam, P.A., where he litigated cases in both state and federal court and handled multiple appeals and arbitrations; and

WHEREAS, prior to and throughout his career, Mr. Fackler found a calling to service to both his profession and the community; in 1996 he joined the United States Peace Corps and spent two years teaching English in Rybnik, Poland; in 2016 he began serving on the Advisory Committee for the United States District Court, Middle District of Florida, and in 2022 he was appointed to the Jacksonville Area Legal Aid Board of Directors; he also served as a board member and President of the Jacksonville Historical Society; and

WHEREAS, in further recognition of Mr. Fackler's distinguished career, he was named one of Florida's "Legal EliteTM" in 2012, 2020 and 2021, and has been honored as a "Super Lawyer" since 2016; and

WHEREAS, Mayor Deegan has determined that the interests of the Consolidated Government will be best served by appointing Michael T. Fackler as General Counsel; and

WHEREAS, the Council finds that Michael T. Fackler is duly qualified to serve as the City of Jacksonville's General Counsel and that Mayor Deegan's appointment of Michael T. Fackler as General Counsel should be confirmed; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. Confirmation. The Council hereby confirms the Mayor's appointment of Michael T. Fackler as the General Counsel for the City of Jacksonville pursuant to Section 7.03 of the Charter of the City of Jacksonville. The resume of the General Counsel is attached hereto as Exhibit 1.

Parties Pursuant to Council Rule 4.1103. Upon introduction of this Resolution, the Legislative Services Division is directed to notify the Clerk of Court, Property Appraiser, Sheriff, Supervisor of Elections, Tax Collector and Chairperson of the Duval County School Board and encourage them to provide oral or written input and guidance to the Rules Committee and any other committee considering this appointment, as to the fitness of the appointee to be General Counsel, in accordance with Council Rule 4.1103 (Confirmation of the General Counsel).

Section 3. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
