I am very disappointed and concerned with your recent decision to support an executive order for the mask mandate. I understand the covid-19 pandemic must be a very difficult issue to try and lead a city through, but this mandate is an extreme overreach to our civil liberties as American citizens. Not only is it an overreach, but there is no significant data that shows wearing masks will reduce or stop the spread of the disease. In fact, there are many studies that show the negative health effects that wearing a mask can induce on healthy people (OSHA, CDC and WHO all have made this statement). The recent uptick in cases, as you very well know, is due to much more testing being available and does not accurately show the true numbers. From all accounts that I have read, hospitalizations and more importantly deaths are way down. The current trend to try and flatten the curve and or reduce the spread is showing to be detrimental to the City, State and Country's economy. We cannot avoid this disease and it is not going to just pack up and leave. The best defense is herd immunity and that will only be obtainable by exposure so that the general public can build their immunity to the disease. With a less than 1% death rate it is ridiculous to create this panic and cripple the local economy. It's pretty simple to me that if you are sick stay home, if you are high risk stay home but the rest of us should carry on as normal. I urge you to recall this mandate and allow the city to start picking up the pieces that the overreaction to this disease has created.

Additionally, The attempt to override the ADA is deplorable. There are many that shouldn't wear masks for health reasons. My son being one. Myself being another and we should not have to disclose these reasons to business's in order to enter and even then we can still be turned away. It is against HIPPA and many other discrimination laws.

There is no scientific reason children should be forced to wear masks. They are not at risk and shouldn't have their health mandated to be put at risk to save other people. This is setting a terrible precedent for the upcoming school year. My son is also deaf in one ear. If the teachers are wearing masks and he can't see their lips, we will be sorely disadvantaged and currently he has a 4.5 gpa and is consistently scoring in the 95-99th percentile on standardized testing. His future should not be at risk for the minuscule chance it could potentially keep someone else from getting sick. What about his rights? He has already been presumed positive for COVID19, there are no well documented cases of someone catching it twice. He is not at risk for infecting anyone. We must open our schools normally. We cannot sustain or rebuild our economy without our children being able to go full time and with these grievous stipulations. This virus has proven to have a 0.04 percent fatality rate in those under the age of 70. This is a far reached overreaction to a virus that barely affects the majority of the population.

There is much evidence that masks used in properly can actually INCREASE the spread of not only COVID19 but many other illnesses. The public is not using masks correctly and neither are employees in business's. Nor are they using proper masks. I am disgusted by a waiter handing me my plate after seeing him or her touch their mask and then my plate. I feel it puts us more at risk than them not wearing them at all.

I hope you will reconsider the mandatory mask mandates. They are a clear violation of our civil rights. If someone wants to wear a mask, that should be their choice and not one forced upon us.

Your supporters do not support a mask mandate. Hello City Council,

I hope this email finds you all well. I am a Jacksonville resident and first I want to say I am so happy that City Council mandated a mask regulation.

I have some suggestions for enforcing the new mask mandate as well as enforcing businesses regulations of 50% capacity, social distancing 6 feet apart. My main suggestion is to follow in the footsteps of South Florida's local governments and make all businesses that serve the public accountable. I'm familiar with Broward's guidelines as my family resides there and they own a restaurant. When Broward realized that unfortunately some businesses were not following the local regulations, they established a hotline that customers and employees can call if they feel a business is not following protocol. Broward promoted this hotline through their social media/website/email campaigns and of course their local media. They also submitted a mandate that all businesses post visible signs inside and outside of their business promoting the hotline.

The only way this will work is by being clear what the repercussions are to businesses not following the regulations and not enforcing customers to wear masks. If the city establishes specific fines and shutdowns Jacksonville businesses will become the city's enforcers of the public because they don't want to get fined and/or shut down. It's the same as the "No shirt, no shoes, no business." policy. If a business can deny service to a customer who is not within their company's dress code then they can absolutely refuse business to someone who is not following Duval County regulations to wear a mask. I have no doubt this system will work for Jacksonville as it is working for Broward.

You can do one better than a hotline and also create an email or an online form where people can submit their findings and attach photos or upload videos. You could add it to the coj.net website and the MyJax app under the Submit Request/Report tab.

If not my suggestions, I implore City Council to develop some kind of system to enforce the regulations. I have been to 3 restaurants since phase 2 opening and all 3 were not abiding by the 50% capacity, 6 feet apart tables. Last night, I went to Harvey's downtown and I noticed about 50% of the employees and some customers were wearing their masks below their mouths.

Jacksonville businesses really need to be held accountable. They truly are the reason for the increase of COVID cases.

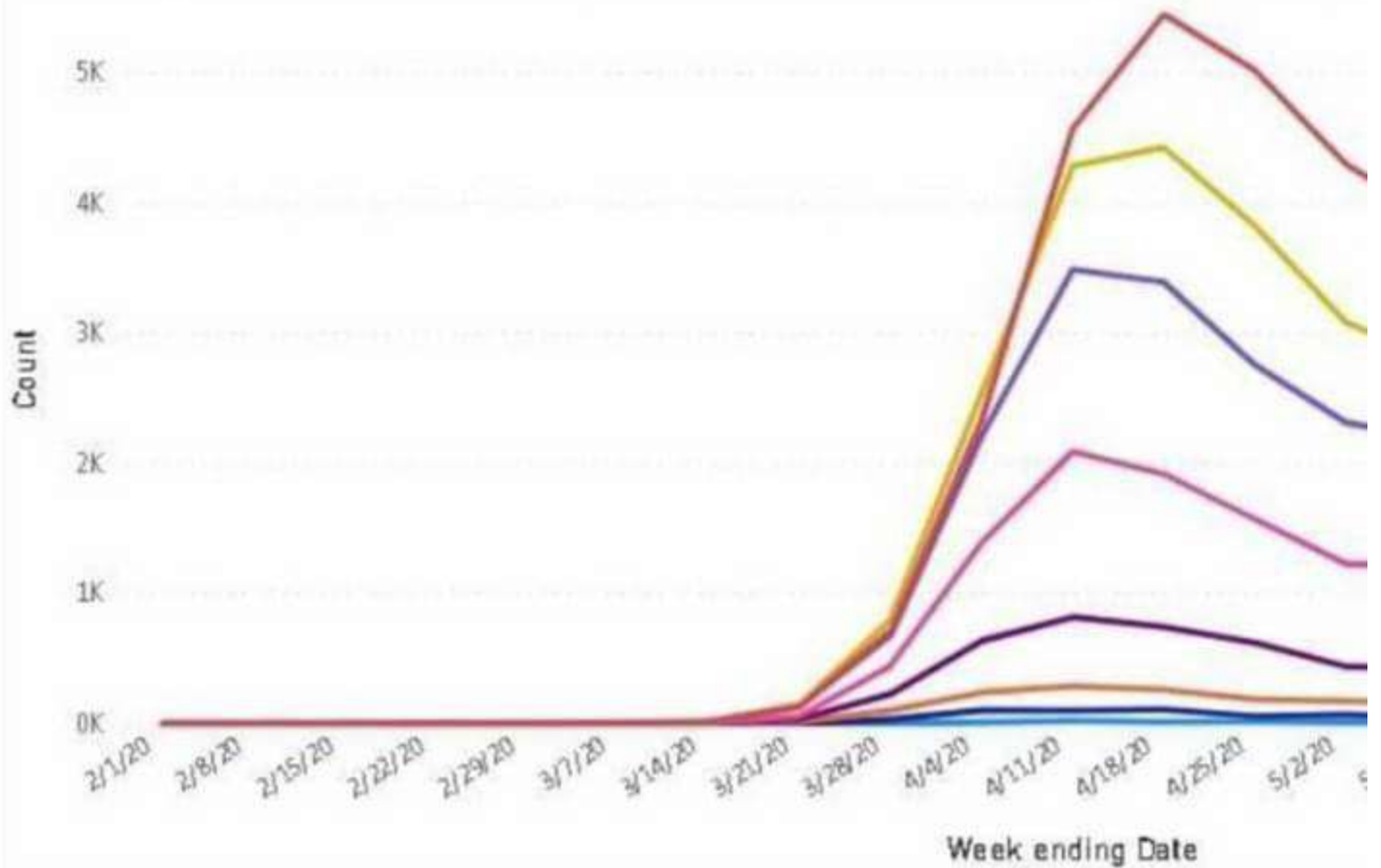

That would be ridiculous, so why is it okay to do the same to those of us with an underlying medical condition that makes it hard to breathe with any sort of face covering?

My 8 year old son has severe autism and cannot wear a mask due to his sensory processing disorder and you have just given businesses the okay to illegally refuse service and access to a CHILD!

Even if you did rescind the discriminatory clause , those of us without masks would be easily identified as being disabled and our bare face would be a sort of scarlet letter or yellow star if you will, leaving us vulnerable to harassment by the public.

The data does not support the mandate for mask.

More testing will yield more cases , yes , but our hospitalizations and deaths are steadily going down.

We have almost 1 million residents and there have been only 64 deaths!

How can you justify taking away the constitutional rights !

Attached is the statement from the ADA issued to remind businesses and local government that ALL the rules still apply during this COVID situation.

Also is the actual direct threat clause , which clearly states how it is to be applied . No business or mayor or council can make a generalized determination on who poses a threat.

(a) This part does not require a public accommodation to permit an individual to participate in or benefit from the goods, services, facilities, privileges, advantages and accommodations of that public accommodation when that individual poses a direct threat to the health or safety of others.

(b) Direct threat means a significant risk to the health or safety of others that cannot be eliminated by a modification of policies, practices, or procedures, or by the provision of auxiliary aids or services.

(c) In determining whether an individual poses a direct threat to the health or safety of others, a public accommodation must make an individualized assessment, based on reasonable judgment that relies on current medical knowledge or on the best available objective evidence, to ascertain: the nature, duration, and severity of the risk; the probability that the potential injury will actually occur; and whether reasonable modifications of policies, practices, or procedures will mitigate the risk.
