4 **ORDINANCE 2024-747**

5 AN ORDINANCE APPROPRIATING \$455,000.00 FROM THE
6 UNDERDRAIN REPLACEMENTS PROJECT TO THE
7 BROOKSHIRE COURT UNDERDRAIN REHABILITATION
8 PROJECT (THE "PROJECT") TO PAY FOR THE REMOVAL
9 AND REPLACEMENT OF APPROXIMATELY 835 FEET OF
10 EXISTING UNDERDRAIN ON BROOKSHIRE COURT, AS
11 INITIATED BY B.T. 24-145; AMENDING THE 2024-2028
12 FIVE-YEAR CAPITAL IMPROVEMENT PLAN APPROVED BY
13 ORDINANCE 2023-505-E TO REFLECT THIS
14 APPROPRIATION OF FUNDS TO THE PROJECT; PROVIDING
15 FOR OVERSIGHT BY THE TRAFFIC ENGINEERING
16 DIVISION OF THE DEPARTMENT OF PUBLIC WORKS;
17 PROVIDING AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
21 within the City's budget, there is hereby appropriated the indicated
22 sum(s) from the account(s) listed in subsection (a) to the account(s)
23 listed in subsection (b):

30 (c) Explanation of Appropriation:
31 The funding above represents an appropriation of

1 \$455,000.00 from the Underdrain Replacements Project to
2 the Brookshire Court Underdrain Rehabilitation Project.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to transfer funds from the Underdrain Replacements
5 Project to the Brookshire Court Underdrain Rehabilitation Project
6 (the "Project") for the construction and installation of the Project.
7 The Project will entail removal and replacement of approximately 835
8 feet of existing underdrain on Brookshire Court and tie into the
9 existing inlet drainage system. The Project will reduce driveway
10 flooding along Brookshire Court and improve drainage at surrounding
11 ponds.

12 **Section 3. Capital Improvement Plan Amendment.** Ordinance
13 2023-505-E, adopting the 2024-2028 Five-Year Capital Improvement Plan
14 (the "CIP") for the City and certain of its independent agencies, is
15 hereby amended to reflect the appropriation of funds to the Project,
16 as more fully described in the Project Information Sheets attached
17 hereto as **Exhibit 2**, and incorporated herein by this reference. The
18 City Council finds that the deferral of this amendment of the CIP
19 until the next annual budget and CIP review will be detrimental to
20 the best interests of the community because such deferral will
21 unnecessarily delay the commencement and completion of the Project.

22 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of
23 this Ordinance requires the affirmative vote of two-thirds of the
24 City Council members present at the meeting because of the CIP
25 amendment set forth in this section. This Ordinance shall constitute
26 an amendment to Ordinance 2023-505-E. In all other respects, the
27 Five-Year Capital Improvement Plan approved by Ordinance 2023-505-E
28 shall remain unchanged and continue in full force and effect.

29 **Section 4.** The Traffic Engineering Division of the
30 Department of Public Works shall have oversight with respect to the
31 project described herein.

1 **Section 5. Effective Date.** This Ordinance shall become
2 effective upon signature by the Mayor or upon becoming effective
3 without the Mayor's signature.
