ORDINANCE 2025-304-E

AN ORDINANCE APPROVING A REVISED TERM SHEET AND BUDGET, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A THIRD AMENDMENT TO THE FY 2023-2024 CITY GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND ABILITY HOUSING, INC. FOR THE PERMANENT SUPPORTIVE HOUSING PILOT PROGRAM (THE "PROGRAM"), AS ORIGINALLY AUTHORIZED BY ORDINANCE 2023-847-E, TO INCORPORATE A REVISED TERM SHEET AND BUDGET FOR THE PROGRAM AS DESCRIBED HEREIN; PROVIDING FOR CONTINUED OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval and Authorization to Execute. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City a third amendment to the FY 2023-2024 City Grant Agreement between the City of Jacksonville and Ability Housing, Inc. (City Contract No. 673659-24) for the Permanent Supportive Housing Pilot Program as originally authorized by Ordinance 2023-847-E, subject to the revised Term Sheet and Budget attached hereto as **Revised Exhibit**

1 **1**, labeled as "Revised Exhibit 1, Rev Term Sheet & Budget, June 2,
2 2025 - NCSPHS" and incorporated herein by this reference, and all
3 other contracts and documents, including extensions, renewals and
4 amendments to the agreement, and to otherwise take all action
5 necessary to effectuate the intent of this Ordinance, subject to
6 appropriate legal review and approval by the General Counsel, or his
7 or her designee, and the City's Risk Management Division for
8 appropriate insurance and indemnification requirements in accordance
9 with Section 128.601, *Ordinance Code*.

10 **Section 2. Oversight.** The Grants and Contract Compliance
11 Division of the Finance Department shall continue to oversee the
12 project described herein.

13 **Section 3. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
