9 RESCUE DEPARTMENT'S EMERGENCY PREPAREDNESS  
10 DIVISION TO EQUIP THE JACKSONVILLE FIRE AND  
11 RESCUE DEPARTMENT WITH SENSORY KITS, AS  
12 INITIATED BY B.T. 25-071; PROVIDING OVERSIGHT BY

18 **Section 1. Appropriation.** For the 2024-2025 fiscal year,

29 The funding above represents an appropriation of funds from  
30 the City of Jacksonville Disabled Services Sponsorship  
31 Program for the REVAMP Duval project.

1           **Section 2.           Purpose.**   The purpose of the appropriation in  
2 Section 1 is to utilize funding from the City of Jacksonville Disabled  
3 Services Sponsorship Program to expand the REVAMP Duval project and  
4 equip all Jacksonville Fire and Rescue Division rescue units with  
5 sensory kits.   The sensory kits are intended to provide first  
6 responders with additional tools to improve interactions with  
7 individuals who have cognitive or sensory impairments.

8           **Section 3.           Oversight.**   The Jacksonville Fire and Rescue  
9 Department Emergency Preparedness Division shall oversee  
10 administration of the project described herein.

11           **Section 4.           Effective Date.**   This Ordinance shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
