PURPOSE: White Paper (Explain Why this legislation is necessary? Provide; Who, What, When, Where, How and the Impact.) Section 111.226, Jacksonville Municipal Code, creates the Victim's Assistance Advisory Council Trust Fund. This fund is used to accept public and private contributions to provide funding for the annual luncheon of the Mayor's Victim Assistance Advisory Council ("VAAC") and other VAAC activities. All sums placed into the Fund, which shall include all interest earned or accrued thereon, are appropriated to the VAAC for its use toward attaining its purposes, functions and goals, and shall not lapse at the close of any fiscal year but instead shall carry over to the next fiscal year. The Director of Finance and Administration, or his/her designee, is authorized and directed to make disbursements of up to \$10,000 per year without further Council approval. This bill authorizes the acceptance and appropriation of \$163,370, being donated by All Elite Wrestling and Farah and Farah, to fund the programs listed in the distribution memo which is an exhibit to the ordinance.
