5 AN ORDINANCE APPROVING, AND AUTHORIZING THE
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN
8 SECOND AMENDMENT TO LICENSE AGREEMENT (OFFICE
9 SPACE WITHIN BUILDING) BETWEEN THE CITY OF
10 JACKSONVILLE AND LUTHERAN SERVICES FLORIDA,
11 INC., A FLORIDA NOT FOR PROFIT CORPORATION, TO
12 EXTEND THE TERM OF THE LICENSE AGREEMENT FOR
13 APPROXIMATELY 2,000 SQUARE FEET OF OFFICE SPACE
14 WITHIN THE KIDS HOPE ALLIANCE BUILDING, LOCATED
15 AT 1095 A. PHILIP RANDOLPH BOULEVARD, BUILDING
16 1, JACKSONVILLE, FLORIDA 32206, FOR A TERM OF
17 SIX (6) MONTHS TO EXPIRE ON JUNE 30, 2025;
18 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
19 PROVIDING FOR OVERSIGHT BY KIDS HOPE ALLIANCE;
20 PROVIDING AN EFFECTIVE DATE.

22 **WHEREAS**, the City of Jacksonville ("City") and Lutheran Services
23 Florida, Inc. ("Licensee") previously entered into that certain
24 License Agreement dated April 13, 2021, as amended by that certain
25 First Amendment dated June 1, 2024 (collectively, the "License
26 Agreement"), as authorized by Ordinance 2020-760-E for the licensed
27 use by Licensee of approximately 2,000 square feet of office space
28 in Building 1 of the Kids Hope Alliance Building, located at 1095 A.
29 Philip Randolph Boulevard, Building 1, Jacksonville, Florida, 32206
30 (the "License Area");

31 **WHEREAS**, the License is scheduled to expire on December 31, 2024

1 and the parties now wish to enter into an amendment to the License
2 to extend the term for an additional six months; now therefore

3 **BE IT ORDAINED** by the Council of the City of Jacksonville:

4 **Section 1. Second Amendment to License Agreement Approved**
5 **and Execution Authorized.** There is hereby approved, and the Mayor,
6 or her designee, and Corporation Secretary are hereby authorized to
7 execute and deliver, that certain Second Amendment to License
8 Agreement between the City and Licensee, in substantially the form
9 attached hereto as **Exhibit 1**. The Second Amendment extends the term
10 of the License Agreement for a term of six (6) month until June 30,
11 2025.

12 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
13 **to Council Rule 4.901 Emergency.** One cycle emergency passage of
14 this legislation is requested. The nature of the emergency is that
15 the License Agreement is set to expire on December 31, 2024, the
16 board of Kids Hope Alliance approved the Second Amendment on November
17 20, 2024, and one cycle passage of this bill will enable the parties
18 to extend the License Agreement prior to expiration.

19 **Section 3. Oversight.** Kids Hope Alliance shall oversee
20 the License Agreement described herein.

21 **Section 4. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
