4 **ORDINANCE 2023-36-E**

5 AN ORDINANCE APPROPRIATING \$692,132 FROM GENERAL
6 FUND/FUND BALANCE TO THE CITY VENUE FUNDS TO
7 PROVIDE FUNDING FOR THE JACKSONVILLE JAGUARS NFL
8 PLAYOFF GAME SCHEDULED FOR JANUARY 14, 2023, AS
9 INITIATED BY B.T. 23-039; PROVIDING FOR
10 OVERSIGHT BY THE DIVISION OF SPORTS AND
11 ENTERTAINMENT; REQUESTING EMERGENCY PASSAGE
12 UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2022-2023 fiscal
16 year, within the City's budget, there are hereby appropriated the
17 indicated sum(s) from the account(s) listed in subsection (a) to the
18 account(s) listed in subsection (b):

25 (c) **Explanation of Appropriation** - The funding above is being
26 appropriated from General Fund/fund balance to the city
27 venue funds to provide funding for the 2023 Jacksonville
28 Jaguars playoff football game scheduled for January 14,
29 2023.

30 **Section 2. Purpose.** The purpose of the appropriation in
31 Section 1 is to provide \$692,132 in funding to SMG, a subsidiary of

1 ASM Global, Inc., as the City's facilities manager for TIAA Bank
2 Field to fund stadium and game day expenses for the Jacksonville
3 Jaguars playoff football game scheduled for January 14, 2023.

4 **Section 3. Oversight.** The Division of Sports and
5 Entertainment shall oversee the project described herein.

6 **Section 4. Requesting Emergency Passage Upon Introduction**
7 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon
8 introduction of this legislation is requested. The nature of the
9 emergency is that the playoff game occurs the weekend of January 14,
10 2023 and the funding is necessary for ASM Global to prepare and
11 operate TIAA Bank Field to host the playoff game.

12 **Section 5. Effective Date.** This Ordinance shall
13 become effective upon signature by the Mayor or upon becoming
14 effective without the Mayor's signature.
