

FLOOR AMENDMENT

The Floor Leader offers the following Floor Amendment to File No. 2025-504:

- (1) Appropriate \$13,992,794 in additional ad valorem revenue arising from the millage rate not being reduced including: (1) \$13,478,133 to a Budget Stabilization account in the General Fund/GSD, (2) \$187,111 to Subsidies and Contributions to Other Government within the Jax Beach Tax Increment District, and (3) \$327,550 to the Unallocated Plan Authorized Expenditure account in the applicable Tax Increment Districts, as follows:

- (3) On page 23, line 21, page 24, line 6, page 25, lines 3-4, and page 79, line 20, strike "Revised Schedule B" and insert "Second Revised Schedule B";
- (4) On page 75, lines 30 and 31 and page 80, line 30, strike "Revised Schedule S" and insert "Second Revised Schedule S";

- (5) On page 76, lines 14 and 15 and page 81, line 1, strike "Revised Schedule T" and insert "Second Revised Schedule T";
- (6) On page 76, lines 29 and 30 and page 81, line 4, strike "Revised Schedule V" and insert "Second Revised Schedule V";
- (7) Remove **Revised Schedule A** and replace with **Second Revised Schedule A**, attached hereto, which attaches the second revised Schedule A to reflect \$13,992,794 in additional ad valorem revenue to be allocated as follows: (1) \$13,478,133 to a Budget Stabilization account in the General Fund/GSD, (2) \$187,111 to Subsidies and Contributions to Other Government within the Jax Beach Tax Increment District, and (3) \$327,550 to the Unallocated Plan Authorized Expenditure account in the applicable tax increment districts;
- (8) Remove **Revised Schedule B** and replace with **Second Revised Schedule B**, attached hereto, which attaches the second revised Schedule B to reflect the impact of not reducing the millage rate within the applicable funds;
- (9) Remove **Revised Schedule S** and replace with **Second Revised Schedule S**, attached hereto, which attaches the second revised Schedule S to reflect \$33,031 in additional ad valorem revenue in the Renew Arlington Tax Increment District with that amount being appropriated to the Unallocated Plan Authorized Expenditure account;
- (10) Remove **Revised Schedule T** and replace with **Second Revised Schedule T**, attached hereto, which attaches the second revised Schedule T to reflect \$53,763 in additional ad valorem revenue in the King Soutel Crossing Tax Increment District with that amount being appropriated to the Unallocated Plan Authorized Expenditure account;

- (11) Remove **Revised Schedule V** and replace with **Second Revised Schedule V**, attached hereto, which attaches the second revised Schedule V to reflect \$162,142 in additional ad valorem revenue in the Northbank Tax Increment District and \$78,614 in additional ad valorem revenue in the Southbank Tax Increment District with said amounts being appropriated to the Unallocated Plan Authorized Expenditure account within the applicable Tax Increment District;
- (12) The Office of General Counsel and the Council Auditor's Office are authorized to make all changes to titles, tables of content, Ordinance Code, journal entries, schedules, attachments, editorial and text changes consistent with the changes set forth herein to 2025-504 to effectuate the Council's action;
- (13) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
