An unopened and unimproved portion of the Asland Road right-of-way, established in 18 the Plat of Garden City, as recorded in Plat Book 5, page 81 of the 19 20 current public records of Duval County, Florida, located in Council 21 District 8, a depiction and description of which is attached hereto 22 as **Exhibit 1**, and incorporated herein by this reference, is hereby 23 closed and abandoned and/or disclaimed as a right-of-way at the 24 request of Toni Daniels Lee (the "Applicant");

The Applicant paid the right-of-way closure application fee of \$2,091.00 and this sum has been deposited into the City's General Fund account. This closure request was reviewed and approved by the various city, state, and utility agencies that might have an interest in the right-of-way and there were no objections to the Applicant's request.

Section 2. Purpose. The Applicant owns property adjacent

1 to the closure area at 0 Asland Road (R.E. No. 019908-0005). The 2 Applicant has requested the closure in order to construct a home and 3 install a fence.

Section 3. Hold Harmless Covenant. The 4 closure and abandonment by the City of its interests in the right-of-way is 5 subject to Applicant's execution and delivery to the City of a Hold 6 7 Harmless Covenant, in substantially the same form attached hereto as Exhibit 2, incorporated herein by this reference. Accordingly, the 8 9 closure and abandonment of the right-of-way shall not be recorded in 10 the public records until execution and delivery to the City by the Applicant of the required Hold Harmless Covenant. 11

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
