4 **ORDINANCE 2026-287**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN
8 INTERLOCAL AGREEMENT BETWEEN THE STATE OF
9 FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND
10 THE CITY OF JACKSONVILLE FOR ALLOCATION AND
11 IMPLEMENTATION OF NATIONAL POLLUTANT DISCHARGE
12 ELIMINATION SYSTEM (NPDES) REQUIREMENTS;
13 PROVIDING FOR OVERSIGHT BY THE OFFICE OF
14 ADMINISTRATIVE SERVICES, ENVIRONMENTAL QUALITY
15 DIVISION; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Approval and authorization.** There is hereby
19 approved, and the Mayor, or her designee, and the Corporation
20 Secretary are hereby authorized to execute and deliver for and on
21 behalf of the City, that certain Interlocal Agreement between the
22 State of Florida Department of Transportation (FDOT) and the City of
23 Jacksonville ("City") for the allocation and implementation of
24 National Pollutant Discharge Elimination System (NPDES) program
25 requirements (the "Agreement"), in substantially the same form as
26 placed **On File** with the Legislative Services Division. The FDOT holds
27 a NPDES Municipal Separate Storm Sewer Phase 1 Permit, which includes
28 a monitoring plan (MS4 permit). The Agreement will allow FDOT to
29 support the work of the City, including funding certain costs,
30 associated with water quality sampling, Illicit Discharge Detection
31 and Elimination (IDDE), High Risk Facility Inspection (HRF) and

1 reporting requirements associated with the MS4 permit. The Agreement
2 term commences on June 1, 2026, and expires on May 31, 2031. The
3 Agreement outlines the budget for the first three years of the term
4 with the remaining budget to be determined by the FDOT prior to May
5 31, 2029.

6 **Section 2. Oversight.** The Office of Administrative
7 Services, Environmental Quality Division shall have oversight of the
8 project described herein.

9 **Section 3. Effective Date.** This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
