

Business Impact Estimate

AN ORDINANCE APPROPRIATING \$143,710 FROM GENERAL FUND OPERATING RESERVES TO THE HISTORIC STANTON REHAB - SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT TO PROVIDE GRANT FUNDS TO HISTORIC STANTON, INC. FOR CERTAIN IMPROVEMENTS TO THE HISTORIC STANTON SCHOOL BUILDING LOCATED AT 521 WEST ASHLEY STREET (THE "PROJECT") AS DESCRIBED HEREIN; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS; WAIVER AND DISCLOSURES), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO ALLOW FOR A DIRECT CONTRACT WITH HISTORIC STANTON, INC.; WAIVING SUBSECTION 118.201(F)(7) (RELEASE OF APPROPRIATIONS), PART 2 (DISBURSEMENT OF CITY GRANTS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO ALLOW FOR AN ADVANCE PAYMENT OF UP TO 25% OF THE TOTAL GRANT AMOUNT TO HISTORIC STANTON, INC.; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND HISTORIC STANTON, INC. FOR THE PROJECT; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE
