## FLOOR AMENDMENT

Council Member White offers the following Floor Amendment to File No. 2023-677:

- (1) On page 1, line 23, after "PROGRAM" <u>insert</u> ", AS INITIATED BY REVISED B.T. 24-007; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY THAT CERTAIN MISCELLANEOUS APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND FIRST COAST CRIME STOPPERS, INC.; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR ADVANCE PAYMENT TO FIRST COAST CRIME STOPPERS, INC.";
- (2) On page 1, line 31, and page 2, lines 3 and 5, <u>strike</u> "B.T. 24-007" and insert "Revised B.T. 24-007";
- (3) On page 1, line 31, <u>strike</u> "Exhibit 1" and <u>insert</u> "Revised
  Exhibit 1, labeled as "Revised Exhibit 1, Rev B.T. 24-007, October 16, 2023 - NCSPHS"";
- (4) On page 2, line 8, <u>strike</u> "from" and <u>insert</u> "in Contributions from Private Sources within";
- (5) On page 2, line 17, strike "patril" and insert "patrol";
- (6) On page 2, line 25, after "Program." <u>insert</u> "A Certification from the Jacksonville Sheriff's Office that the subject appropriation from the Special Law Enforcement Trust Fund complies with Section 932.7055, *Florida Statutes*, is attached hereto as **Exhibit 2** and incorporated herein by this reference.";

(7) On page 2, line 25 <sup>1</sup>/<sub>2</sub>, <u>insert</u> a new Section 3 and Section 4 to read as follows:

"Section 3. Approval and Authorization. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City that certain Miscellaneous Appropriations Agreement between the City of Jacksonville and First Coast Crime Stoppers, Inc., in substantially the form attached hereto as **Exhibit 3** and incorporated herein by this reference (the "Agreement").

Section 4. Waiving Section 110.112, Ordinance Code. Section 110.112 (Advance of City funds; prohibition against), Part 1 (The City Treasury), Chapter 110 (City Treasury), Ordinance Code, is hereby waived to allow for advance payment to First Coast Crime Stoppers, Inc. as provided in the Agreement.";

- (8) Renumber remaining Section accordingly;
- (9) Remove Exhibit 1 and replace with Revised Exhibit 1, attached hereto, which attaches the revised B.T. 24-007 to correct the account codes;
- (10) Attach Exhibit 2, attached hereto, which attaches the certification of compliance with Section 932.7055, Florida Statutes;
- (11) Attach Exhibit 3, attached hereto, which attaches the Miscellaneous Appropriations Agreement between the City of Jacksonville and First Coast Crime Stoppers, Inc.;
- (12) On **page 1**, **line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
