4 **ORDINANCE 2024-769**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE  
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER A SECOND  
8 AMENDMENT TO THE FY 2021-2022 CITY GRANT  
9 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND  
10 REGIONAL FOOD BANK OF NORTHEAST FLORIDA, INC.  
11 D/B/A FEEDING NORTHEAST FLORIDA (THE  
12 "AGREEMENT"), TO EXTEND THE TERM OF THE  
13 AGREEMENT TO EXPIRE ON SEPTEMBER 30, 2025, TO  
14 EXTEND CERTAIN OTHER RELATED DATES AND DEADLINES  
15 WITHIN THE AGREEMENT, TO REVISE THE AGREEMENT TO  
16 PROVIDE THAT THE CITY FUNDS WILL BE USED FOR A  
17 ROOF REPLACEMENT AT REGIONAL FOOD BANK OF  
18 NORTHEAST FLORIDA, INC. D/B/A FEEDING NORTHEAST  
19 FLORIDA'S NEW LOCATION AT 5245 OLD KINGS ROAD,  
20 AND TO AMEND THE OVERALL PROJECT COST TO \$1.2  
21 MILLION WITH ALL FUNDING BEING PROVIDED BY THE  
22 CITY; PROVIDING FOR CONTINUED OVERSIGHT BY THE  
23 GRANTS AND CONTRACT COMPLIANCE DIVISION;  
24 PROVIDING AN EFFECTIVE DATE.

26 **WHEREAS**, Ordinance 2021-504-E (the FY 21-22 Budget Ordinance)  
27 appropriated \$1,200,000 to Regional Food Bank of Northeast Florida,  
28 Inc. d/b/a Feeding Northeast Florida ("FNEFL") for the Farmers Market  
29 and Resource Center and authorized the Mayor, or her designee, and  
30 the Corporation Secretary to execute, on behalf of the City, a grant  
31 agreement between the City and FNEFL; and

1           **WHEREAS**, the term of the FY 2021-2022 City Grant Agreement  
2 between the City of Jacksonville and FNEFL (the "Agreement") dated  
3 September 21, 2022, as amended by that First Amendment dated September  
4 18, 2023, is currently set to expire on September 30, 2024; and

5           **WHEREAS**, FNEFL has requested an extension to the term of the  
6 Agreement and further is requesting to use a portion of the City  
7 funds to replace the roof at FNEFL's new facility; and

8           **WHEREAS**, the City Council therefore desires to extend the term  
9 of the Agreement to September 30, 2025, and to amend the Agreement  
10 to authorize use of the City funds for replacement of the roof at  
11 FNEFL's new facility at 5245 Old Kings Road; now therefore

12           **BE IT ORDAINED** by the Council of the City of Jacksonville:

13           **Section 1. Approval and Authorization to Execute an**  
14 **Amendment to Agreement.** There is hereby approved, and the Mayor, or  
15 her designee, and the Corporation Secretary are hereby authorized to  
16 execute and deliver a second amendment to the FY 2021-2022 City Grant  
17 Agreement between the City of Jacksonville and Regional Food Bank of  
18 Northeast Florida, Inc. d/b/a Feeding Northeast Florida ("FNEFL")  
19 (City Contract #72025-22) (the "Agreement"), to extend the term of  
20 the Agreement to September 30, 2025, to extend related dates based  
21 on the extension to the term authorized herein, to revise the  
22 Agreement to authorize use of the City funds for a roof replacement  
23 at FNEFL's new location at 5245 Old Kings Road, and to amend the  
24 overall project cost to \$1.2 million with all funding coming from the  
25 City. All other provisions including the clawback provisions and  
26 reimbursement will remain in place except as needed to account for  
27 the extension of time and use of the City funds. The extension  
28 authorized herein will be retroactive to October 1, 2024, to ensure  
29 there is no lapse in the contract term.

30           **Section 2. Oversight.** The Office of Economic Development  
31 shall continue to have oversight of the Agreement described herein.

1           **Section 3.           Effective Date.**   This Ordinance shall become  
2 effective upon signature by the Mayor or upon becoming effective  
3 without the Mayor's signature.
