9 ACCOUNT TO PROVIDE FUNDING TO ENGAGE A
10 CONSULTANT TO BRING TOGETHER REPRESENTATIVES
11 FROM VARIOUS HOMEOWNER AND NEIGHBORHOOD
12 ASSOCIATIONS WITHIN COUNCIL DISTRICT 6 WITH A
13 GOAL OF CREATING AN ENTITY AND/OR PLAN THAT
14 DRAWS CONSENSUS AND ARTICULATES A VISION FOR
15 COUNCIL DISTRICT 6; PROVIDING FOR CARRYOVER OF
16 FUNDS TO FISCAL YEAR 2025-2026; PROVIDING FOR
17 OVERSIGHT BY THE PLANNING AND DEVELOPMENT

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
22 within the City's budget, there is hereby appropriated the indicated
23 sum(s) from the account(s) listed in subsection (a) to the account(s)
24 listed in subsection (b):

1 The funding above is an appropriation of \$152,362 from a
2 General Fund Operating Special Council Contingency account
3 to the Council District 6 Community Study - Other
4 Professional Services account to provide funding to engage
5 a consultant to coordinate with various homeowner and
6 neighborhood associations to create an entity and/or plan
7 that can organize and articulate a vision for Council
8 District 6 with a focus on preservation and beautification.

9 **Section 2. Purpose.** The purpose of the appropriation in
10 Section 1 is to provide funds to engage a consultant to bring together
11 representatives from various homeowner and neighborhood associations
12 within Council District 6 with a goal of creating an entity and/or
13 plan that draws consensus and articulates a vision for Council
14 District 6 with a focus on the priorities of preservation and
15 beautification.

16 **Section 3. Carryover.** The funds appropriated herein shall
17 not lapse but shall carryover to fiscal year 2025-2026.

18 **Section 4. Oversight Department.** The Planning and
19 Development Department shall oversee the project described herein.

20 **Section 5. Effective Date.** This Ordinance shall become
21 effective upon signature by the Mayor or upon becoming effective
22 without the Mayor's signature.
