Section 111.630, Ordinance Code, is a permanent special revenue fund into which the City annually deposits an amount equal to 1% of the approved economic development agreement monetary commitments by the City to developers during a calendar year for inclusion in the next annual budget.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding to the Jacksonville Upward Mobility Program to build the capacity of existing programs and/or create new programs geared towards the training, education, and maintenance of a sustainable local workforce, consistent with Section 180.103, Ordinance Code.
