ORDINANCE 2021-852-E

AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING AND STREET NAMING REGULATIONS) ORDINANCE CODE; TO CLARIFY AND RE-NAME "TAMPA AVENUE RIGHT OF WAY" CURRENTLY LOCATED SEVERAL BLOCKS NORTHEAST OF THE "TAMPA AVENUE" STREET SIGN AS "DROAD STREET"; WAIVING THE REQUIREMENTS OF SECTION 745.105 (c), ORDINANCE CODE, WHICH REQUIRES THE PLANNING AND DEVELOPMENT DEPARTMENT TO SEND WRITTEN NOTIFICATION TO AFFECTED PROPERTY OWNERS; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO FORWARD THIS ORDINANCE TO THE PLANNING AND DEVELOPMENT DEPARTMENT AND THE PUBLIC WORKS DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Planning and Development Department's Addressing
Unit received an address request for a residence located on Tampa
Avenue; and

WHEREAS, there exists a "Tampa Avenue", and a "Tampa Avenue Right of Way;" and

WHEREAS, several residences are currently assigned with a "Tampa Avenue" address; and

WHEREAS, the Tampa Avenue Right of Way is designated as an unopened Right of Way, and no homes are addressed from "Tampa Avenue" in that location; and

WHEREAS, the street sign for "Tampa Avenue" is located several blocks southwest of the Tampa Avenue Right of Way; and

WHEREAS, the Council seeks to re-name "Tampa Avenue Right of Way" to "Droad Street"; and

WHEREAS, on August 4, 2021, the 911 Emergency Addressing Advisory Committee voted to accept the Staff Recommendation to rename "Tampa Avenue Right of Way" to "Broad Street". A copy of the minutes of the August 4, 2021, public meeting of the 911 Emergency Addressing Advisory Committee is attached as Exhibit 1; and

WHEREAS, on September 22, 2021, the Jacksonville Historic Preservation Commission ("JHPC") voted to adopt the Staff Report with a recommendation for approval to re-name "Tampa Avenue Right of Way" to "Droad Street." A copy of the JHPC agenda, Staff Report, and the excerpt minutes of the September 22, 2021, public meeting of the Jacksonville Historic Preservation Commission are attached hereto as Exhibit 2; and

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Tampa Avenue Right of Way re-named as "Droad Street." The Tampa Avenue Right of Way is hereby re-named to "Droad Street" by which name such street and physical location shall be hereafter known and designated. A copy of the map of "Tampa Avenue" is attached hereto as Exhibit 3.

Section 2. Waiver of Section 745.105 (c), Ord. Code.

Section 745.105(c), Ordinance Code, which requires that the Planning and Development Department send written notifications to affected property owners is hereby waived as the Ordinance clarifies the correct physical location of "Tampa Avenue" and re-names "Tampa Avenue Right of Way" to "Droad Street" which is an unopened Right of Way having no address assignments.

Section 3. Legislative Services Division directed to forward a copy to the Planning and Development Department and the Public Works Department. The Chief of Legislative Services is directed to send a copy of this legislation once enacted to the Planning and

Development Department, Addressing Unit, and the Public Works Department for processing, implementation, and coordination with 911 Emergency, Fire and Rescue Department, the U.S. Postal Service, Google and other affected agencies and organizations.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
