5 AN ORDINANCE APPROPRIATING \$490,655.69 IN
6 GRANT FUNDS FROM THE U. S. DEPARTMENT OF
7 JUSTICE, BUREAU OF JUSTICE ASSISTANCE, THROUGH
8 THE STATE ATTORNEY'S OFFICE, FOURTH JUDICIAL
9 CIRCUIT OF FLORIDA, UNDER THE FISCAL YEAR 2018
10 NATIONAL SEXUAL ASSAULT KIT INITIATIVE (SAKI),
11 WITH NO LOCAL MATCH, TO PROVIDE SALARIES AND
12 BENEFITS TO TWO FULL-TIME COLD CASE DETECTIVES
13 IN FISCAL YEAR 2020 AND ONE FULL-TIME COLD
14 CASE DETECTIVE IN FISCAL YEAR 2021 WHO WILL
15 WORK EXCLUSIVELY ON SAKI, AS INITIATED BY B.T.
16 20-006; APPROVING AND AUTHORIZING THE MAYOR,
17 OR HIS DESIGNEE, AND THE CORPORATION SECRETARY
18 TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF
19 THE CITY, THE SUBCONTRACT BETWEEN THE STATE
20 ATTORNEY'S OFFICE, 4TH JUDICIAL CIRCUIT, AND
21 THE JACKSONVILLE SHERIFF'S OFFICE (JSO);
22 PROVIDING FOR OVERSIGHT BY THE JSO DEPARTMENT
23 OF INVESTIGATIONS AND HOMELAND SECURITY;
24 APPROVING POSITIONS, AS INITIATED BY R.C. 20-
25 006; PROVIDING FOR AN EFFECTIVE DATE.

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
29 within the City's budget, there is hereby appropriated the
30 indicated sum from the account listed in subsection (a) to the
31 account listed in subsection (b):

7 (c) Explanation of Appropriation.

8 The funding above is a grant from the U. S. Department of
9 Justice, Bureau of Justice Assistance, through the State
10 Attorney's Office, Fourth Judicial Circuit of Florida,
11 under the Fiscal Year 2018 National Sexual Assault Kit
12 Initiative (SAKI). No local match is required. The grant
13 period is from October 1, 2018, through September 30,
14 2021. A copy of the sub-award letter from the State
15 Attorney's Office is attached hereto as **Exhibit 2** and
16 incorporated herein by this reference.

17 **Section 2. Purpose.** The purpose of the appropriation in
18 Section 1 is to provide salaries and benefits to two full-time cold
19 case detectives in Fiscal year 2020 and one full-time cold case
20 detective in Fiscal Year 2021. The detectives will work exclusively
21 on SAKI.

22 **Section 3. Approval and authorization.** There is hereby
23 approved, and the Mayor, or his designee, and Corporation Secretary
24 are hereby authorized to execute and deliver, for and on behalf of
25 the City, the Subcontract between the State Attorney's Office, 4th
26 Judicial Circuit, and the Jacksonville Sheriff's Office (JSO), a
27 copy of which has been placed **ON FILE** with the Office of
28 Legislative Services.

29 **Section 4. Oversight.** The JSO Department of
30 Investigations and Homeland Security shall oversee the project
31 described herein.

1 **Section 5. Approval of Positions.** There is hereby
2 approved the positions more fully described in R.C. 20-006,
3 attached hereto as **Exhibit 3** and incorporated herein by this
4 reference.

5 **Section 6. Effective Date.** This ordinance shall become
6 effective upon signature by the Mayor or upon becoming effective
7 without the Mayor's signature.
