AN ORDINANCE APPROPRIATING GRANT FUNDING IN THE AMOUNT OF \$640,000 FROM THE STATE OF FLORIDA, DEPARTMENT OF TRANSPORTATION, TO THE MCDUFF AVENUE ROADWAY IMPROVEMENTS – OTHER CONSTRUCTION COSTS ACCOUNT, TO PROVIDE FUNDING TO ADD LANES AND FOR RECONSTRUCTION OF MCDUFF AVENUE FROM OLGA PLACE TO STATE ROUTE 15/U.S. 17/ROOSEVELT BOULEVARD; AMENDING THE 2026-2030 FIVE-YEAR CAPITAL IMPROVEMENT PROGRAM APPROVED BY ORDINANCE 2025 505-E TO CREATE A NEW PROJECT ENTITLED “MCDUFF AVENUE ROADWAY IMPROVEMENTS” (THE “PROJECT”) AND TO REFLECT THIS APPROPRIATION OF FUNDS TO THE PROJECT; PROVIDING FOR OVERSIGHT BY THE ENGINEERING AND CONSTRUCTION MANAGEMENT DIVISION OF THE DEPARTMENT OF PUBLIC WORKS; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.
