4 **ORDINANCE 2026-330**

5 AN ORDINANCE CLOSING AND ABANDONING AND/OR  
6 DISCLAIMING A 5-FOOT-WIDE DRAINAGE EASEMENT,  
7 ESTABLISHED IN THE PLAT OF GROVE PARK UNIT 4, AS  
8 RECORDED IN PLAT BOOK 33, PAGE 5 AND 5A, OF THE  
9 CURRENT PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA,  
10 LOCATED IN COUNCIL DISTRICT 4, AT THE REQUEST OF  
11 CHARLES AND GAIL NELSON; PROVIDING FOR APPROVAL  
12 SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE  
13 DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Closure and Abandonment.** A 5-foot-wide drainage  
17 easement as established in the Plat of Grove Park Unit 4, as recorded  
18 in Plat Book 33, Page 5 and 5A, of the current public records of  
19 Duval County, Florida, located in Council District 4, a depiction and  
20 description in substantially the forms placed **On File** with the  
21 Legislative Services Division and incorporated herein by this  
22 reference, is hereby closed and abandoned and/or disclaimed at the  
23 request of Charles and Gail Nelson (the "Applicant").

24 The Applicant has paid the \$1,582.00 easement closure  
25 application fee with encroachment and this sum has been deposited  
26 into the City's General Fund. This closure request was reviewed and  
27 approved by the various city, state, and utility agencies that might  
28 have an interest in the right-of-way and there were no objections to  
29 the Applicant's request.

30 **Section 2. Purpose.** The Applicant has requested this  
31 closure to construct a garage in the rear yard of their homestead

1 property (see R.E. No. 140543-000 for reference). The closure area  
2 is not currently in use, and this will not change with the closure;  
3 however, the closure will increase the setback required to construct  
4 a garage near the area.

5 **Section 3. Hold Harmless Covenant.** The closure and  
6 abandonment by the City of its interests in the right-of-way is  
7 subject to Applicant's execution and delivery to the City of a Hold  
8 Harmless Covenant, in substantially the form placed **On File** with the  
9 Legislative Services Division and incorporated herein by this  
10 reference. Accordingly, the closure and abandonment of the right-of-  
11 way shall not be recorded in the public records until execution and  
12 delivery to the City by the Applicant of the required Hold Harmless  
13 Covenant.

14 **Section 4. Effective Date.** This Ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
