4 **ORDINANCE 2024-837**

5 AN ORDINANCE APPROPRIATING \$301,038.70 FROM THE
6 OPIOID SETTLEMENT FUND INVESTMENT POOL EARNINGS
7 TO THE OPIOID SETTLEMENT FUND - SUBSIDIES AND
8 CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT
9 TO PROVIDE ADDITIONAL FUNDS FOR OPIOID AND
10 SUBSTANCE USE DISORDER SETTLEMENT PROCEEDS
11 GRANTS IN FISCAL YEAR 2024-2025; PROVIDING AN
12 EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
16 within the City's budget, there are hereby appropriated the indicated
17 sum(s) from the account(s) listed in subsection (a) to the account(s)
18 listed in subsection (b):

25 (c) Explanation of Appropriation:

26 The funding above is an appropriation from the designated
27 Opioid Settlement Fund Investment Pool Earnings to the
28 Opioid Settlement Fund - Subsidies and Contributions to
29 Private Organizations account to provide additional funds
30 for Opioid and Substance Use Disorder Settlement Proceeds
31 Grants ("OSUD Grants") in Fiscal Year 2024-2025.

1 **Section 2. Purpose.** The purpose of the appropriation in
2 Section 1 is to provide funds for OSUD Grants to be awarded to
3 qualified requesting agencies in Fiscal Year 2024-2025 in accordance
4 with Chapter 84 (Opioid Settlement Proceeds Grants), *Ordinance Code*.
5 Section 84.301 (Opioid Settlement Proceeds Allocation for Opioid
6 Settlement Proceeds Grants), *Ordinance Code*, requires that 70% of
7 Opioid Settlement Proceeds deposited in the Opioid Settlement Special
8 Revenue Fund during the immediately preceding calendar year shall be
9 included in the Mayor's annual budget to fund OSUD Grants in the
10 upcoming fiscal year. The funds appropriated herein comprise 70% of
11 the total interest collected on all Opioid Settlement Proceeds dollars
12 deposited in the Opioid Settlement Special Revenue Fund through
13 September 30, 2024.

14 **Section 3. Effective Date.** This Ordinance shall become
15 effective upon signature by the Mayor or upon becoming effective
16 without the Mayor's signature.
