7 GENERATED FROM HELP AMERICA VOTE ACT (HAVA)  
8 GRANT FUNDS AWARDED BY THE U.S. ELECTION  
9 ASSISTANCE COMMISSION THROUGH THE STATE OF  
10 FLORIDA, DEPARTMENT OF STATE, DIVISION OF  
11 ELECTIONS, TO PAY FOR THE MAILING OF SAMPLE  
12 BALLOTS, AS INITIATED BY B.T. 24-126; PROVIDING  
13 FOR CARRYOVER OF FUNDS INTO FISCAL YEAR 2024-  
14 2025; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
18 within the City's budget, there are hereby appropriated the indicated  
19 sum(s) from the account(s) listed in subsection (a) to the account(s)  
20 listed in subsection (b):

27 (c) **Explanation of Appropriation** - The funding above represents  
28 investment pool earnings generated from the Help America  
29 Vote Act (HAVA) grant from the U.S. Election Assistance  
30 Commission through the State of Florida, Department of  
31 State, Division of Elections, and will be used for the

1 mailing of sample ballots.

2 **Section 2. Purpose.** The purpose of the appropriation in  
3 Section 1 is to provide funding to the City for the mailing of sample  
4 ballots. The State of Florida, Department of State, Division of  
5 Elections, has requested that all remaining funds related to the HAVA  
6 grant program be used to close out the program.

7 **Section 3. Carryover.** The funds appropriated in this  
8 Ordinance shall not lapse but shall carryover to fiscal year 2024-  
9 2025.

10 **Section 4. Effective Date.** This Ordinance shall become  
11 effective upon signature by the Mayor or upon becoming effective  
12 without the Mayor's signature.
