

## RULES AMENDMENT

The Rules Committee offers the following amendment to File No. 2024-31:

- (1) On **page 1, line 5, strike** "\$229,962.47," and **insert** "\$227,891.50";
- (2) On **page 1, lines 13-14, strike** "B.T. 24-022; PROVIDING FOR CARRYOVER OF FUNDS" and **insert** "SECOND REVISED B.T. 24-022; APPROVING, AND AUTHORIZING THE SUPERVISOR OF ELECTIONS TO EXECUTE AND DELIVER ON BEHALF OF THE CITY THE MEMORANDUM OF AGREEMENT FOR 2022-2023 ELECTION SECURITY ENHANCEMENT GRANT FUNDS AWARDED BETWEEN THE STATE OF FLORIDA, DEPARTMENT OF STATE, DIVISION OF ELECTIONS AND THE SUPERVISOR OF ELECTIONS FOR DUVAL COUNTY, FLORIDA";
- (3) On **page 1, line 19, strike** "2023-2024" and **insert** "2022-2023";
- (4) On **page 1, lines 23, 26 and 28, strike** "Revised B.T. 24-022" and **insert** "Second Revised B.T. 24-022";
- (5) On **page 1, line 23, strike** "Exhibit 1" and **insert** "Revised Exhibit 1, labeled as "Revised Exhibit 1, 2<sup>nd</sup> Rev B.T. 24-022, February 20, 2024 - Rules"";
- (6) On **page 1, lines 26 and 28, strike** "\$229,962.47" and **insert** "\$227,891.50";
- (7) On **page 2, line 11, strike** "On File" and **insert** "Revised On File";
- (8) On **page 2, lines 12-14, strike** Section 4 in its entirety and **insert** a new Section 3 to read as follows:

**Section 3. Approval and Authorization.** There is hereby approved, and the Supervisor of Elections is hereby

authorized to execute and deliver on behalf of the City the Memorandum of Agreement for 2022-2023 Election Security Enhancement Grant for Subscription for Albert Network Monitoring, Voting Technology Upgrades or Enhancements and/or for Improving Voting Accessibility between the State of Florida, Department of State, Division of Elections and the Supervisor of Elections for Duval County, Florida.”;

- (9) Renumber the remaining Sections accordingly;
- (10) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the second revised B.T. 24-022 to correct the appropriation amount, year and accounts;
- (11) Remove **On File**, and replace with **Revised On File**, attached hereto, which attaches the revised Memorandum of Agreement for 2022-2023 Election Security Enhancement Grant to include Attachments A and B;
- (12) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
