AN ORDINANCE APPROPRIATING A \$1,000,000 GRANT FROM THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY ("EPA") FOR CLIMATE POLLUTION REDUCTION ACTIVITIES THAT INCLUDE ESTABLISHMENT OF A GREEN HOUSE GAS INVENTORY AND THE CREATION IMPLEMENTATION OF A CLIMATE ACTION PLAN FOR THE JACKSONVILLE METROPOLITAN STATISTICAL AUTHORIZING PART-TIME HOURS, AS INITIATED BY R.C. 24-040; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2026-2027; PROVIDING FOR OVERSIGHT BY THE PLANNING AND DEVELOPMENT DEPARTMENT; REQUESTING ONE-CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

Explanation of Appropriation: (C)

> The funding above represents an appropriation of grant funds in the amount of \$1,000,000 from the United States Environmental Protection Agency ("EPA") for climate control reduction activities to combat greenhouse gases.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for climate control reduction activities in Jacksonville. Specifically, the funded project will entail the establishment of a Greenhouse Gas Inventory and the creation and implementation of a climate action plan for the Jacksonville Metropolitan Statistical Area (the "Project"). Project activities will include development of greenhouse gas emission projections, reduction measures and targets, and various components of a climate action plan that would include elements for interagency and intergovernmental coordination, public and stakeholder engagement, and a low-income/disadvantaged communities benefit analysis. The intent of the Project is to use the Greenhouse Gas Inventory to map out implementation measures to reduce greenhouse gas emissions. Once the implementation measures are identified, this will provide the City an opportunity to compete for additional grant funding to pay for phase two of the grant.

This award is subject to the terms and conditions outlined in the U.S. Environmental Protection Agency Grant Agreement attached hereto as Exhibit 2. The grant period commenced on September 1, 2023 and will continue through August 31, 2027. A local match is not required for receipt of these grant funds.

Section 3. Approval of Part-Time Hours. There are hereby approved the part-time hours more fully described in R.C. 24-040, attached hereto as Exhibit 3, and incorporated herein by this reference.
