7 AN ORDINANCE APPROPRIATING \$91,240.00 FROM
8 AVAILABLE REVENUE BALANCE IN THE DOMESTIC
9 BATTERY SURCHARGE TRUST FUND (THE "FUND") TO
10 ESTABLISH THE FISCAL YEAR 2022-2023 OPERATING
11 BUDGET FOR THE FUND AND TO PROVIDE ADDITIONAL
12 TRAINING TO LAW ENFORCEMENT PERSONNEL IN
13 COMBATING DOMESTIC VIOLENCE, AS INITIATED BY
14 B.T. 23-011; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
18 within the City's budget, there is hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

28 The funding above is an appropriation of available revenue
29 from County Court fines and investment pool earnings in
30 the Domestic Battery Surcharge Trust Fund (the "Fund") to
31 establish the fiscal year 2022-2023 operating budget for

1 the Fund.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to establish the fiscal year 2022-2023 operating budget
4 for the Domestic Battery Surcharge Trust Fund. The funds will be
5 used to provide additional training to law enforcement personnel in
6 combating domestic violence. There are no requirements for a local
7 match, nor will there be additional staffing obligations or ongoing
8 maintenance costs associated with this appropriation.

9 **Section 3. Effective Date.** This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
