6 A RESOLUTION CONFIRMING THE APPOINTMENT OF  
7 KAREN ESTELLA SMITH AS A MEMBER OF THE  
8 CULTURAL SERVICE GRANT PROGRAM COMMITTEE, AS  
9 ONE OF THE SEVEN COMMUNITY REPRESENTATIVES,  
10 REPLACING SANDRA HULL-RICHARDSON, PURSUANT TO  
11 SECTION 118.605, *ORDINANCE CODE*, FOR PARTIAL  
12 TERM EXPIRING DECEMBER 31, 2021; PROVIDING AN  
13 EFFECTIVE DATE.

15 **WHEREAS**, pursuant to §118.605(a), *Ordinance Code*, the  
16 membership of the Cultural Service Grant Program Committee shall be  
17 comprised of 10 members (3 Cultural Council Board Members and 7  
18 individuals from the community appointed by the Cultural Council  
19 Board President, Cultural Service Grant Program Committee Chair,  
20 and the 3 Cultural Council Board Members); and

21 **WHEREAS**, pursuant to §118.605(d), *Ordinance Code*, all members  
22 of the Cultural Service Grant Program Committee shall be confirmed  
23 by the City Council; and

24 **WHEREAS**, 2019-268-A appointed Sandra Hull-Richardson to the  
25 Cultural Service Grant Program Committee with a term ending  
26 December 31, 2021 as a community representative; and

27 **WHEREAS**, the Cultural Council Board would like to amend Ms.  
28 Hull-Richardson's category of community representative to the  
29 Cultural Council of Greater Jacksonville Board Member  
30 representative with a term end date of December 31, 2021; and

31 **WHEREAS**, Resolution 2020-397 has been introduced to reappoint

1 Ms. Hull-Richardson to the Cultural Service Grant Program Committee  
2 as a Cultural Council of Greater Jacksonville Board Member  
3 representative, leaving the Community representative seat open; now  
4 therefore

5 **BE IT RESOLVED** by the Council of the City of Jacksonville:

6 **Section 1. Confirmation.** The Council hereby confirms the  
7 appointment of Karen Estella Smith, a Duval County resident, to the  
8 Cultural Service Grant Program Committee, as a community  
9 representative, replacing Sandra Hull-Richardson in accordance with  
10 Sec. 118.605, *Ordinance Code*, for partial term ending December 31,  
11 2021.

12 **Section 2. Effective Date.** This resolution shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
