5 **RESOLUTION 2023-287**

6 A RESOLUTION DESIGNATING APRIL 28, 2023, AS
7 "WORKERS MEMORIAL DAY" IN JACKSONVILLE IN
8 RECOGNITION OF WORKERS INJURED, KILLED, OR MADE
9 ILL IN THE WORKPLACE; REQUESTING EMERGENCY
10 PASSAGE UPON INTRODUCTION; PROVIDING AN
11 EFFECTIVE DATE.

13 **WHEREAS**, on December 29, 1970, President Richard Nixon signed
14 into law the Occupational Safety and Health Act (OSHA), which went
15 into effect on April 28, 1971; and

16 **WHEREAS**, despite the existence of OSHA, which was intended to
17 provide American workers the right to a safe workplace and requires
18 employers to provide safe conditions, tens of thousands of American
19 workers are killed by workplace injuries and occupational disease
20 every year and tens of thousands more workers are permanently
21 disabled, injured, or made ill; and

22 **WHEREAS**, various organizations including the Northeast Florida
23 Safety Council, First Coast Manufacturers Association, Associated
24 Builders and Contractors - First Coast Chapter, Northeast Florida
25 Builders Association, American Society of Safety Professionals, and
26 the employers these organizations represent are determined to prevent
27 these tragedies and rededicate their efforts to improving workplace
28 safety, seeking stronger health standard enforcement, and treating
29 workers with dignity as constant improvements in worker safety are
30 pursued; and

31 **WHEREAS**, each April, Workers Memorial Day is observed as a day

1 to remember those who have suffered and died on the job; and

2 **WHEREAS,** since 1989, workers, employers and local government
3 leaders have gathered on April 28th to commemorate those who have lost
4 their lives while working to provide a good standard of living for
5 their families and communities; and

6 **WHEREAS,** Americans can honor our workers by observing Workers
7 Memorial Day as a day to remember those victims of workplace injuries
8 and disease and by rededicating ourselves to improving safety and
9 health in every American workplace; now therefore

10 **BE IT RESOLVED** by the Council of the City of Jacksonville:

11 **Section 1.** The City of Jacksonville hereby designates
12 Friday, April 28, 2023, as "Workers Memorial Day" in Jacksonville and
13 asks all citizens to recognize and honor all workers killed, injured,
14 disabled, or made ill on the job, thank them for their service, offer
15 sympathy to their families and loved ones, and to respect today's
16 workers by providing safe workplaces.

17 **Section 2. Requesting Emergency Passage Upon Introduction**
18 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon
19 introduction of this Resolution is requested in order to recognize
20 Workers Memorial Day in a timely manner.

21 **Section 3. Effective Date.** This Resolution shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
