AN ORDINANCE APPROPRIATING \$100,000 FROM THE NORTHWEST OED FUND - CONTINGENCY ACCOUNT, TO THE NORTHWEST OED FUND - SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT, FOR THE PURPOSE OF PROVIDING A NORTHWEST JACKSONVILLE ECONOMIC DEVELOPMENT FUND ("NWJEDF") BUSINESS INFRASTRUCTURE GRANT (THE "BIG GRANT") ТО BAKER'S SPORTS, INC. ("COMPANY") TO FUND CERTAIN INFRASTRUCTURE IMPROVEMENTS IN CONNECTION WITH THE RENOVATION OF AN EXISTING BUILDING ON THE PROPERTY LOCATED AT 5245 COMMONWEALTH AVENUE ("PROJECT"), AS INITIATED BY B.T. 25-104; MAKING CERTAIN FINDINGS, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, AN ECONOMIC DEVELOPMENT AGREEMENT BETWEEN THE CITY AND COMPANY, TO SUPPORT THE PROJECT; AUTHORIZING THE BIG GRANT; AUTHORIZING APPROVAL TECHNICAL AMENDMENTS BY THE OF EXECUTIVE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT ("OED"); AFFIRMING THE PROJECT'S COMPLIANCE WITH THE NWJEDF GUIDELINES APPROVED AND ADOPTED BY ORDINANCE 2016-779-E, AS AMENDED; PROVIDING FOR CITY OVERSIGHT BY THE OED; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Baker's Sports, Inc. (the "Company") is seeking

public investment through the Northwest Jacksonville Economic Development Fund in the amount of \$100,000.00, which consists of a Northwest Business Infrastructure Grant (the "BIG Grant"), in order to support certain infrastructure improvements related to the renovation of an existing building on the property located at 5245 Commonwealth Avenue (the "Project"); and

7 WHEREAS, the Company estimates capital investment of approximately \$900,000 and will support the retention of 165 existing 8 9 full-time jobs and 10 part-time jobs and the creation of an additional 10 30 full-time equivalent jobs, as further described in the Project Summary, attached hereto as **Exhibit 1**, and incorporated herein by 11 12 this reference; and

WHEREAS, for the reasons more fully described in the Project Summary, the payment of the BIG Grant in the aforesaid amount serves a paramount public purpose; and

16 WHEREAS, the recommended level of assistance is within Public 17 Investment Guidelines for a Northwest BIG Grant; and

18 WHEREAS, the Project will have a positive return of investment 19 for the City; and

20 WHEREAS, the Office of Economic Development ("OED") has 21 reviewed the application submitted by the Company for community 22 development and, together with representatives of the City, has 23 negotiated an Economic Development Agreement ("EDA") and, based upon 24 the contents of the EDA, has determined the EDA and the uses 25 contemplated therein to be in the public interest, and has determined 26 that the public actions and financial assistance contemplated in the 27 EDA take into account and give consideration to the long-term public 28 interests and public interest benefits to be achieved by the City; 29 and

30 WHEREAS, the Company has requested the City to enter into the 31 EDA in substantially the form placed **On File** with the Legislative

2 BE IT RESOLVED by the Council of the City of Jacksonville:
3 Section 1. Findings. It is hereby ascertained, determined,
4 found and declared as follows:

(a) The recitals set forth herein are true and correct.

6 (b) The location of the Company's Project in Jacksonville, 7 Florida, is more particularly described in the EDA. The Project will 8 promote and further the public and municipal purposes of the City.

9 Enhancement of the City's tax base and revenues, are (C) 10 matters of State and City policy and State and City concern in order that the State and its counties and municipalities, including the 11 City, shall not continue to be endangered by unemployment, 12 underemployment, economic recession, poverty, crime and disease, and 13 consume an excessive proportion of the State and City revenues because 14 15 of the extra services required for police, fire, accident, health care, elderly care, charity care, hospitalization, public housing and 16 17 housing assistance, and other forms of public protection, services and facilities. 18

(d) The provision of the City's assistance as identified in the EDA is necessary and appropriate to make the Project feasible, and the City's assistance is reasonable and not excessive, taking into account the needs of the Company to make the Project economically and financially feasible and the extent of the public benefits expected to be derived from the Project.

(e) The Company is qualified to carry out and complete the construction and equipping of the Project, in accordance with the EDA.

(f) The authorizations provided by this Ordinance are for public uses and purposes for which the City may use its powers as a county, municipality and as a political subdivision of the State of Florida and may expend public funds, and the necessity in the public

interest for the provisions herein enacted is hereby declared as a 1 2 matter of legislative determination.

3 This Ordinance is adopted pursuant to the provisions of Chapters 163, 166 and 125, Florida Statutes, as amended, the City's Charter, 4 5 and other applicable provisions of law.

6 Section 2. Appropriation. For the 2024-2025 fiscal year, 7 within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) 8 9 listed in subsection (b):

(c) Explanation of Appropriation 16

The funding above is an appropriation of \$100,000 from the 17 Northwest OED Fund - Contingency account, to the Northwest OED Fund 18 19 - Subsidies and Contributions to Private Organizations account, for 20 the purpose of providing a Northwest Jacksonville Economic 21 Development Fund ("NWJEDF") Business Infrastructure Grant to the 22 Company to assist in funding infrastructure improvements to support the renovation of an existing building. 23

24 Section 3. Purpose. The purpose of the appropriation in 25 Section 2 is to provide the Company funding in the form of a Northwest 26 Jacksonville Business Infrastructure Grant in an amount not to exceed 27 \$100,000 to fund infrastructure improvements needed to complete the 2.8 Project.

29 Economic Development Agreement Approved. Section 4. The Mayor, or her designee, and the Corporation Secretary are hereby 30 authorized to execute and deliver, for and on behalf of the City, the 31

EDA between the City and the Company, in substantially the form placed On File with the Legislative Services Division (with such "technical" changes as herein authorized), for the purpose of implementing the recommendations of the OED as set forth herein and further described in the Project Summary, attached hereto as **Exhibit 1**.

The EDA may include such additions, deletions, and changes as 6 7 may be reasonable, necessary, and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor or her designee, 8 9 with such inclusion and acceptance being evidenced by execution of 10 the EDA by the Mayor or her designee. No modification of the EDA may increase the financial obligations or the liability of the City and 11 any such modification shall be technical only and shall be subject 12 to appropriate legal review and approval of the General Counsel or 13 his or her designee and all other appropriate action required by law. 14 "Technical" is herein defined as including, but not limited to, 15 legal descriptions and surveys, descriptions 16 changes in of 17 infrastructure improvements and/or any road project, ingress and egress, easements and rights of way, performance schedules (provided 18 19 that no performance schedule may be extended for more than one year 20 without City Council approval), design standards, access, and site 21 plans which have no financial impact.

22 Designation of Authorized Official/OED Contract Section 5. Monitor. The Mayor is designated as the authorized official of the 23 24 City for the purpose of executing and delivering any contracts, notes, 25 and documents and furnishing such information, data, and documents 26 for the EDA as may be required and otherwise to act as the authorized 27 official of the City in connection with the EDA, and is further 28 authorized to designate one or more other officials of the City to 29 exercise any of the foregoing authorizations and to furnish or cause to be furnished such information and take or cause to be taken such 30 action as may be necessary to enable the City to implement the EDA 31

1 according to its terms. The OED is hereby required to administer and 2 monitor the EDA and to handle the City's responsibilities thereunder, 3 including the City's responsibilities under the EDA working with and 4 supported by all relevant City departments.

Further Authorizations. 5 Section 6. The Mayor, or her 6 designee, and the Corporation Secretary, are hereby authorized to 7 execute the EDA and all other contracts and documents and otherwise take all necessary action in connection therewith and herewith. The 8 9 Executive Director of the OED, as contract administrator, is 10 authorized to negotiate and execute all necessary changes and amendments to the EDA and other contracts and documents, to effectuate 11 the purposes of this legislation without further Council action, 12 provided such changes and amendments are limited to amendments that 13 14 are technical in nature (as described in Section 4 hereof), and further provided that all such amendments shall be subject to 15 appropriate legal review and approval by the General Counsel, or his 16 17 or her designee, and all other appropriate official action required by law. 18

19 Section 7. Oversight Department. The OED shall oversee the 20 Project described herein.

Section 8. NWJEDF Guidelines. This Ordinance conforms to the NWJEDF Guidelines adopted by City Council Ordinance 2016-779-E, as amended.

Section 9. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
