5 AN ORDINANCE APPROPRIATING \$150,000 FROM GENERAL  
6 FUND OPERATING FUND BALANCE TO THE CCSS COUNCIL  
7 STAFF SERVICES OTHER PROFESSIONAL SERVICES  
8 ACCOUNT FOR THE CITY COUNCIL'S ENGAGEMENT OF AN  
9 ECONOMIC DEVELOPMENT CONSULTANT; REQUESTING ONE  
10 CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
15 within the City's budget, there are hereby appropriated the indicated  
16 sum(s) from the account(s) listed in subsection (a) to the account(s)  
17 listed in subsection (b):

25 The funding above comprises an appropriation of \$150,000  
26 from General Fund Operating fund balance to the CCSS  
27 Council Staff Services Other Professional Services Account  
28 to procure the professional services of a consultant to  
29 advise the City Council on matters of economic development.

30 **Section 2. Purpose.** The purpose of the appropriation in  
31 Section 1 is to provide funds for the City Council to engage the

1 professional services of an independent consultant specifically to  
2 advise the Council on various economic development projects and  
3 proposals.

4           **Section 3.           Requesting One Cycle Emergency Passage Pursuant**  
5 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
6 legislation is requested. The nature of the emergency is that the  
7 Council would like to engage a consultant as soon as possible  
8 recognizing there are several significant economic development  
9 projects anticipated to come before the City Council for consideration  
10 over the coming year.

11           **Section 4.           Effective Date.** This Ordinance shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
