4 **ORDINANCE 2024-773**

5 AN ORDINANCE APPROPRIATING \$1,000,000 FROM THE  
6 CONTINGENCY ACCOUNT TO THE CONTRIBUTION TO-FROM  
7 COMPONENT UNIT ACCOUNT WITHIN THE HOMELESSNESS  
8 INITIATIVES SPECIAL REVENUE FUND TO PROVIDE A  
9 CONTRIBUTION TO JACKSONVILLE HOUSING FINANCE  
10 AUTHORITY (JHFA) TO SUPPORT DEVELOPMENT OF  
11 MULTIFAMILY AFFORDABLE HOUSING IN DUVAL COUNTY;  
12 WAIVING THE CONFLICTING PROVISIONS OF SECTION  
13 111.920 (HOMELESSNESS INITIATIVES SPECIAL  
14 REVENUE FUND), PART 9 (NEIGHBORHOOD  
15 DEVELOPMENT), CHAPTER 111 (SPECIAL REVENUE AND  
16 TRUST ACCOUNTS), *ORDINANCE CODE*, TO ALLOW FOR  
17 USE OF THE CITY FUNDS APPROPRIATED HEREIN FOR  
18 DEVELOPMENT OF AFFORDABLE HOUSING; AUTHORIZING  
19 THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
20 SECRETARY TO EXECUTE AND DELIVER AN INTERLOCAL  
21 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND  
22 JHFA; PROVIDING FOR OVERSIGHT BY THE  
23 NEIGHBORHOODS DEPARTMENT; PROVIDING AN  
24 EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2024-2025 fiscal year,  
28 within the City's budget, there is hereby appropriated the indicated  
29 sum(s) from the account(s) listed in subsection (a) to the account(s)  
30 listed in subsection (b):

6 (c) Explanation of Appropriation:

7 The funding above is an appropriation from the Contingency  
8 account to the Contribution To-From Component Unit account  
9 within the Homelessness Initiatives Special Revenue Fund  
10 to provide a \$1,000,000 contribution to Jacksonville  
11 Housing Finance Authority (JHFA) to support the development  
12 of multifamily affordable housing in Duval County.

13 **Section 2. Purpose.** The purpose of the appropriation in  
14 Section 1 is to provide funding to JHFA to support development of  
15 affordable housing in Duval County. Specifically, these funds will  
16 be used to provide multifamily development loans for the purpose of  
17 financing a portion of the costs related to acquisition and  
18 construction or rehabilitation of multifamily residential housing  
19 facilities. JHFA will administer use of these City funds through its  
20 Multifamily Housing Development Loan Fund (the "Fund) into which JHFA  
21 has agreed to deposit \$1,000,000 in matching funds after deposit of  
22 the City funds appropriated herein. As part of its annual report to  
23 the City pursuant to Section 52.112, *Ordinance Code*, JHFA shall  
24 include a report regarding the Fund and use of the City dollars as  
25 outlined in **Exhibit 2**, attached hereto and incorporated herein by  
26 this reference.

27 **Section 3. Waiving the Conflicting Provisions of Section**  
28 **111.920, Ordinance Code.** Section 111.920 (Homelessness Initiatives  
29 Special Revenue Fund), Part 9 (Neighborhood Development), Chapter 111  
30 (Special Revenue and Trust Accounts), *Ordinance Code*, provides that  
31 all funds deposited into the Homelessness Initiatives Special Revenue

1 Fund shall be used for programs, initiatives, or services for Duval  
2 County's homeless and chronically unhoused populations. The  
3 provisions of Section 111.920, *Ordinance Code*, are hereby waived to  
4 the extent they are in conflict with this appropriation to allow for  
5 use of the City funds appropriated herein for development of  
6 affordable housing. The Council recognizes that development of  
7 additional affordable housing in Duval County offers an opportunity  
8 to the families and individuals placed in the affordable units to  
9 avoid homelessness or to no longer be homeless. In addition, the City  
10 Council Special Committee on Homelessness and Affordable Housing  
11 discussed and recommended use of these funds from the Homelessness  
12 Initiatives Special Revenue Fund to increase the number of affordable  
13 housing units in the City recognizing this should have an impact on  
14 the number of individuals or families who become homeless in the  
15 future.

16 **Section 4. Authorization to Execute Interlocal Agreement.**

17 The Mayor, or her designee, and the Corporation Secretary, are hereby  
18 authorized to execute and deliver, for and on behalf of the City, an  
19 Interlocal Agreement with Jacksonville Housing Finance Authority  
20 subject to the terms and conditions outlined in the Term Sheet  
21 attached hereto as **Exhibit 2**, and all other contracts and documents,  
22 including extensions, renewals and amendments to the Interlocal  
23 Agreement, and to otherwise take all action necessary to effectuate  
24 the intent of this Ordinance, subject to appropriate legal review and  
25 approval by the Office of General Counsel and the City's Risk  
26 Management Division for appropriate insurance and indemnification  
27 requirements in accordance with Section 128.601, *Ordinance Code*.

28 **Section 5. Oversight Department.** The Neighborhoods  
29 Department shall oversee the project described herein.

30 **Section 6. Effective Date.** This Ordinance shall become  
31 effective upon signature by the Mayor or upon becoming effective
