6 A RESOLUTION CONFIRMING THE APPOINTMENT OF
7 ANGELA STRAIN AS A MEMBER OF THE CULTURAL
8 SERVICE GRANT PROGRAM COMMITTEE, REPLACING
9 DAVID FALISZEK, AS ONE OF SEVEN COMMUNITY
10 REPRESENTATIVES, PURSUANT TO SECTION 118.605,
11 *ORDINANCE CODE*, FOR A FIRST TERM ENDING
12 DECEMBER 31, 2022; PROVIDING AN EFFECTIVE
13 DATE.

15 **WHEREAS**, pursuant to §118.605(a), *Ordinance Code*, the
16 membership of the Cultural Service Grant Program Committee shall be
17 comprised 1 non-voting member and 10 voting members (3 Cultural
18 Council Board Members and 7 individuals from the community
19 appointed by the Cultural Council Board President, Cultural Service
20 Grant Program Committee Chair, and the 3 Cultural Council Board
21 Members); and

22 **WHEREAS**, pursuant to §118.605(d), *Ordinance Code*, all members
23 of the Cultural Service Grant Program Committee shall be confirmed
24 by the City Council; and

25 **WHEREAS**, 2018-199-A appointed David Faliszek to the Cultural
26 Service Grant Program Committee with a term ending December 31,
27 2019 as a community representative; and

28 **WHEREAS**, the Cultural Council Board would like to amend
29 Faliszek's category of community representative to the Cultural
30 Council of Greater Jacksonville Board Member representative with a
31 term end date of December 31, 2020; and

1 **WHEREAS**, Resolution 2020-398 has been introduced to reappoint
2 Mr. Faliszek to the Cultural Service Grant Program Committee as a
3 Cultural Council of Greater Jacksonville Board Member
4 representative, leaving the Community representative seat open; now
5 therefore

6 **BE IT RESOLVED** by the Council of the City of Jacksonville:

7 **Section 1. Confirmation.** The Council hereby confirms the
8 appointment of Angela Strain, a Duval County resident, to the
9 Cultural Service Grant Program Committee, replacing David Faliszek,
10 as a community representative, in accordance with Sec. 118.605,
11 *Ordinance Code*, for a first term expiring December 31, 2022.

12 **Section 2. Effective Date.** This resolution shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
