6 \$220,551 IN GRANT FUNDING FROM THE UNITED STATES
7 DEPARTMENT OF HOMELAND SECURITY AND \$73,517 IN
8 REQUIRED LOCAL MATCH FUNDS FROM THE GENERAL FUND
9 FOR THE PURCHASE OF SPECIALIZED EMERGENCY
10 PREPAREDNESS EQUIPMENT AND TRAVEL FOR THE
11 FEDERAL EMERGENCY MANAGEMENT AGENCY GRANT
12 MANAGEMENT COURSE, AS INITIATED BY B.T. 26-039;
13 PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE
14 SHERIFF'S OFFICE; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
18 within the City's budget, there is hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

28 The funding above represents an appropriation of \$220,551
29 in grant funds from the United States Department of
30 Homeland Security and \$73,517 in required local match funds
31 from the General Fund for the purchase of specialized

1 emergency preparedness equipment and related travel.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to utilize grant funding from the United States
4 Department of Homeland Security and required local match funds from
5 the General Fund to purchase specialized emergency preparedness
6 equipment in the form of two man-portable bomb disposal robots and
7 travel to attend the Federal Emergency Management Agency grant
8 management course. A copy of the Award Letter for the United States
9 Department of Homeland Security grant funding outlining the terms and
10 conditions relative to the grant and use of the grant funds has been
11 placed **On File** with the Legislative Services Division.

12 **Section 3. Oversight.** The Jacksonville Sheriff's Office
13 shall oversee administration of the grant and project described
14 herein.

15 **Section 4. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
