4 **ORDINANCE 2023-48**

5 AN ORDINANCE AMENDING CHAPTER 656 (ZONING CODE),
6 PART 13 (SIGN REGULATIONS), SUBPART A (GENERAL
7 PROVISIONS), SECTION 656.1309 (UNLAWFUL SIGN
8 MESSAGES), *ORDINANCE CODE*, TO PROHIBIT
9 UNAUTHORIZED SIGNS THAT ARE PROJECTED ONTO
10 BUILDINGS, STRUCTURES OR OTHER PLACES; PROVIDING
11 CODIFICATION INSTRUCTIONS; REQUESTING EMERGENCY
12 PASSAGE UPON INTRODUCTION; PROVIDING AN
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Amending Chapter 656 (Zoning Code), Part 13**
17 **(Sign Regulations), Subpart A (General Provisions), Section 656.1309**
18 **(Unlawful sign messages), Ordinance Code.** Chapter 656 (Zoning Code),
19 Part 13 (Sign Regulations), Subpart A (General Provisions), Section
20 656.1309 (Unlawful sign messages), *Ordinance Code*, is hereby amended
21 to read as follows:

22 **CHAPTER 656**

24 **PART 13. - SIGN REGULATIONS**

25 **SUBPART A. - GENERAL PROVISIONS**

26 * * *

27 **Sec. 656.1309. Unlawful signs.~~Unlawful sign messages.~~**

- 28 (a) Projections of light, laser beams or any other medium
29 to form text, graphics, logos, or artwork upon streets,
30 walkways, fences, sign structures, land or water
31 surfaces, or exterior walls or other exterior portions

1 of buildings or any other structure are prohibited,
2 except that an owner may project a sign onto an exterior
3 portion of his or her own property, building or structure
4 if the area occupied by such sign does not otherwise
5 violate applicable sign regulations included in this
6 Part. The person or business who owns or is advertised
7 or identified on the sign shall be presumed to have
8 permitted the placement of the sign in the absence of
9 credible evidence to the contrary and may be cited for
10 violation of this subsection by either the City's
11 Municipal Code Compliance Division or the Jacksonville
12 Sheriff's Office, and the person or business installing
13 or projecting the sign is also in violation of this
14 subsection. Violations of this subsection shall
15 constitute a class D offense; however, projections of
16 text, graphics, logos, or artwork onto a building,
17 structure or any other place (including public spaces)
18 without the consent of the owner or person in control
19 of the building, structure or space shall constitute
20 blight and graffiti, and pursuant to Sections 806.13 and
21 125.69, Florida Statutes, these violations shall
22 constitute a second degree misdemeanor punishable by a
23 definite term of imprisonment of up to 60 days
24 (discretionary) and a fine not less than \$2000 (non-
25 discretionary), and any equipment or vehicles used in
26 furtherance of this crime shall be seized by the
27 Jacksonville Sheriff's Office and forfeited to the
28 City.~~Reserved.~~

30 **Section 2. Codification Instructions.** The Codifier and the
31 Office of General Counsel are authorized to make all chapter and

1 division "table of contents" consistent with the changes set forth
2 herein. Such editorial changes and any other necessary changes to
3 make the *Ordinance Code* consistent with the intent of this legislation
4 are approved and directed herein, and the changes to the *Ordinance*
5 *Code* shall be made forthwith and when inconsistencies are discovered.

6 **Section 3. Requesting Emergency Passage Upon Introduction**
7 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon
8 introduction of this legislation is requested. The nature of the
9 emergency is that publicly and privately owned lands, buildings and
10 structures are not appropriate venues for installation or display of
11 signage depicting personal or private messages or opinions without
12 the consent of the property owner. Such illegal projections have
13 recently been used to publish the personal messages of the projecting
14 individual, to which the owners of the spaces used to display such
15 personal messages have ardently objected. To ensure the types of
16 displays prohibited by this new Code provision can be immediately
17 enforced by the City's Municipal Code Compliance Division and the
18 Jacksonville Sheriff's Office, emergency passage upon introduction
19 of this legislation is necessary.

20 **Section 4. Effective Date.** This Ordinance shall become
21 effective upon signature by the Mayor or upon becoming effective
22 without the Mayor's signature.
