ORDINANCE 2024-806

AN ORDINANCE AMENDING THE JEA FISCAL YEAR 2023-2024 BUDGET; INCORPORATING RECITALS: AMENDING ORDINANCE 2023-504-E (THE CITY OF JACKSONVILLE BUDGET ORDINANCE) BY AMENDING SCHEDULE C (JEA CONSOLIDATED OPERATING BUDGET) AND SCHEDULE D (JEA CONSOLIDATED CAPITAL BUDGET) TO APPROPRIATE SURPLUS FUNDS FROM FISCAL YEAR 2022-2023 AND ADDITIONAL FUNDS FROM ENVIRONMENTAL - RATE STABILIZATION FUND FOR THE ELECTRIC SYSTEM AND WATER AND WASTEWATER SYSTEM TO INCREASE THE TRANSFER TO OPERATING CAPITAL OUTLAY IN THE OPERATING BUDGET, TO APPROPRIATE EXCESS INVESTMENT INCOME REVENUE IN THE DISTRICT ENERGY SYSTEM OPERATING BUDGET TO TRANSFER TO OPERATING CAPITAL OUTLAY, AND TO APPROPRIATE THE ADDITIONAL TRANSFER FROM OPERATING CAPITAL OUTLAY IN THE ELECTRIC SYSTEM, WATER AND WASTEWATER SYSTEM, AND DISTRICT ENERGY SYSTEM CAPITAL BUDGET; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2023-504-E, which included the 2023-2024 Fiscal Year Operating and Capital Budgets for JEA, was enacted by Council on September 26, 2023; and

WHEREAS, a copy of Schedule C (JEA Consolidated Operating Budget) and Schedule D (JEA Consolidated Capital Budget) approved by Ordinance 2023-504-E are attached hereto as Exhibit 1; and

WHEREAS, on September 24, 2024, the JEA Board approved Board

Resolution 2024-60, attached hereto as **Exhibit 2**, which recommended amending Ordinance 2023-504-E to amend the fiscal year 2023-2024 JEA Consolidated Operating and Capital Budgets to appropriate surplus funds from fiscal year 2022-2023 and additional funds from the Environmental Rate Stabilization fund for the Electric and Water and Wastewater systems and to appropriate excess investment income revenue for the District Energy System to increase the transfer to Operating Capital Outlay within the operating budget and then to appropriate the increased transfer in Operating Capital Outlay in the Electric System, Water and Wastewater System, and District Energy System capital budgets; and

WHEREAS, more specifically, the JEA Board authorized net increases of \$28,156,901 to the operating budget and \$8,126,949 to the capital budget for the Electric System, net increases of \$16,060,655 to the operating budget and \$15,434,805 to the capital budget for the Water and Wastewater System, and an increase of \$200,000 for the District Energy System operating budget as more particularly described in the JEA Board Agenda Memorandum dated September 24, 2024, attached hereto, attached hereto as Exhibit 3; and

WHEREAS, the net increased expenses of \$28,156,901 for the Electric System operating budget are due to an increase of \$2,076,363 in a withdrawal from the Environmental - Rate Stabilization Fund, which is a contra expense, and using \$28,156,901 from the Operating Fund carried over from fiscal year 2022-2023 to increase the transfer to Operating Capital Outlay in the amount of \$30,233,264; and

WHEREAS, the net increased expenses of \$16,060,665 for the Water and Wastewater System operating budget are due to a withdrawal of \$650,000 from the Environmental - Rate Stabilization Fund, which is a contra expense, and using \$16,060,655 from the Operating Fund carried over from fiscal year 2022-2023 to increase the transfer to

 Operating Capital Outlay in the amount of \$16,710,655; and

WHEREAS, the increased expense for the District Energy System operating budget is due to an increase of \$200,000 in the budgeted transfer to Operating Capital Outlay by using excess Investment Income revenue in the current fiscal year; and

WHEREAS, the net increased expenses of \$8,126,949 for the Electric System capital budget are funded by the increased transfer of \$30,233,264 to Operating Capital Outlay and the reduction of Other Proceeds in the amount of \$22,106,315 based on current year capital expenses; and

WHEREAS, the net increased expenses of \$15,434,805 for the Water and Wastewater System capital budget are funded by the increased transfer of \$16,710,665 to Operating Capital Outlay and the reduction of Debt Proceeds in the amount of \$1,275,860 based on current year capital expenses; and

WHEREAS, the District Energy System capital budget includes the increased transfer of \$200,000 to Operating Capital Outlay and has an offsetting decrease in Debt Proceeds resulting no change to total capital expenses; and

WHEREAS, JEA is requesting the City Council approve this amendment to the JEA Consolidated Operating and Capital Budgets for fiscal year 2023-2024; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Amending Ordinance 2023-504-E to Revise Schedule C for the Fiscal Year 2023-2024 JEA Operating Budget and Schedule D for the Fiscal Year 2023-2024 JEA Capital Budget. Sections 2.1 and 2.2 of Ordinance 2023-504-E are hereby amended, in part, to revise Schedules C and D to the JEA budget. The Revised Schedule C and the Revised Schedule D are attached hereto as Exhibit 4, and by this

reference are made a part of Ordinance 2023-504-E.
