A RESOLUTION HONORING AND COMMEMORATING THE LIFE AND ACCOMPLISHMENTS OF SAMUEL DAVIS, JR. UPON THE OCCASION OF HIS PASSING; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Samuel Davis, Jr., a native of Macon, Georgia, moved to Jacksonville as a young child and graduated from Douglas Anderson Junior/Senior High School where he was an outstanding basketball player; and

WHEREAS, Mr. Davis attended Florida Junior College then served in the U.S. Army in Vietnam, earning an Air Medal for meritorious service before returning to Jacksonville after his military service; and

WHEREAS, Samuel Davis studied broadcasting at Jones College and subsequently worked for 36 years for WTLV television, retiring as an operating engineer in 2009. He was also the producer of "Blues Power Productions" inviting blues artists to the North Florida area and was a radio DJ of a blues show and a Sunday morning gospel show on WCGL radio for many years; and

WHEREAS, after his retirement, Mr. Davis devoted much of his time to Douglas Anderson #107 Alumni Association of which he was President. He was instrumental in getting the historical marker for Douglas Anderson High School #107 designated by the State of Florida and for getting an honorary street marker, "Nathaniel S. Washington Sr. Parkway" which is located on White Ave., the street running beside Douglas Anderson School of the Arts. He spent many

hours planning events leading up to the annual schoolwide Grand Reunion and Scholarship Program and also instrumental in developing a partnership between Douglas Anderson Jr. Sr. High School #107 and the current Douglas Anderson School of the Arts. He was also a member of the Douglas Anderson School of the Arts Foundation Board; and

WHEREAS, Samuel Davis was a loving husband and father and a long-time active member of Jerusalem Baptist Church and Bethel Baptist Institutional Church; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City Council hereby honors and commemorates the life and numerous accomplishments of Samuel Davis, Jr. upon the occasion of his passing, and extends to his family, friends and colleagues its sincere condolences. Sam Davis was a great Jacksonvillian and will be sorely missed.
