9 ADMINISTER THE SHERIFF'S GUN BOUNTY PROGRAM, A  
10 PROGRAM THAT SUPPORTS DRUG TREATMENT, DRUG  
11 ABUSE EDUCATION, DRUG PREVENTION, CRIME  
12 PREVENTION, SAFE NEIGHBORHOODS, AND SCHOOL  
13 RESOURCE OFFICER PROGRAMS, AS INITIATED BY  
14 B.T. 20-091; APPROVING AND AUTHORIZING THE  
15 MAYOR, OR HIS DESIGNEE, AND THE CORPORATION  
16 SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF  
17 THE CITY THE MISCELLANEOUS APPROPRIATIONS  
18 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND  
19 FIRST COAST CRIME STOPPERS, INCORPORATED;  
20 PROVIDING AN EFFECTIVE DATE.

22 **BE IT ORDAINED** by the Council of the City of Jacksonville:

23 **Section 1. Appropriation.** For the 2019-2020 fiscal year,  
24 within the City's budget, there are hereby appropriated the  
25 indicated sum(s) from the account(s) listed in subsection (a) to  
26 the account(s) listed in subsection (b):

(c) Explanation of Appropriation

The funding above is an appropriation from the Special Law Enforcement Trust Fund (the "Fund") for a donation to First Coast Crime Stoppers to administer the Sheriff's Gun Bounty Program. The existing revenue balance within the Fund will be used to increase Budgeted Revenues by \$150,000.00 and will increase the appropriation in expenditure by \$150,000.00.

**Section 2. Purpose.** The purpose of the appropriation in Section 1 is to provide a donation to First Coast Crime Stoppers to administer the Sheriff's Gun Bounty Program. This allocation supports drug treatment, drug abuse education, drug prevention, crime prevention, safe neighborhoods, and school resource officer programs. A Certification that the request from the Special Law Enforcement Trust Fund complies with §932.7055, Florida Statutes, is attached hereto as **Exhibit 2** and incorporated herein by this reference.

**Section 3. Approval and authorization.** There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City the Miscellaneous Appropriations Agreement between the City of Jacksonville and First Coast Crime Stoppers, Incorporated, in substantially the same form placed **ON FILE** with the Office of Legislative Services.

**Section 4. Effective Date.** This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
