ORDINANCE 2026-94

AN ORDINANCE APPROPRIATING \$385,000 FROM GENERAL FUND OPERATING RESERVES TO THE JARBOE PARK IMPROVEMENTS - SUBSIDIES AND CONTRIBUTIONS TO OTHER GOVT ACCOUNT, TO PROVIDE FUNDS TO THE CITY OF NEPTUNE BEACH FOR IMPROVEMENTS TO JARBOE PARK LOCATED AT 510 FLORIDA BOULEVARD, NEPTUNE BEACH, FLORIDA 32266; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2026-2027; AUTHORIZING THE MAYOR, OR HER DESIGNEE, TO NEGOTIATE AN AGREEMENT WITH THE CITY OF NEPTUNE BEACH AND THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND THE CITY OF NEPTUNE BEACH FOR IMPROVEMENTS TO JARBOE PARK, SUBJECT TO CERTAIN CONDITIONS; PROVIDING FOR OVERSIGHT BY THE PUBLIC WORKS DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2025-2026 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

3 (c) Explanation of Appropriation:

4 The funding above represents an appropriation of \$385,000
5 from General Fund Operating Reserves to the Jarboe Park
6 Improvements - Subsidies and Contributions to Other Govt
7 account to provide funds to the City of Neptune Beach for
8 improvements to Jarboe Park, located at 510 Florida
9 Boulevard, Neptune Beach, Florida 32266 as more fully
10 described herein.

11 **Section 2. Purpose.** The purpose of the appropriation in
12 Section 1 is to provide funds to the City of Neptune Beach for
13 improvements to Jarboe Park as more fully described in **Exhibit 2**
14 attached hereto and incorporated herein by this reference.

15 **Section 3. Carryover.** The funds appropriated herein shall
16 not lapse but shall carryover to Fiscal Year 2026-2027.

17 **Section 4. Authorization to Negotiate, Execute and Deliver**
18 **Agreement.** The Mayor, or her designee, is hereby authorized to
19 negotiate, and the Mayor, or her designee, and the Corporation
20 Secretary are hereby authorized to execute and deliver on behalf of
21 the City of Jacksonville, an agreement with the City of Neptune Beach
22 to provide funding from the City of Jacksonville to the City of
23 Neptune Beach for improvements to Jarboe Park as more fully described
24 in **Exhibit 2** in a not-to-exceed amount of \$385,000. The Office of
25 General Counsel is authorized to prepare an agreement between the
26 City and the City of Neptune Beach, subject to the provisions of
27 Section 110.112 (Advance of City funds; prohibition against),
28 *Ordinance Code*. The agreement shall include the following provisions:

29 (1) The City of Neptune Beach shall use its
30 Procurement/Purchasing Code to procure goods and services for
31 improvements to Jarboe Park and will only expend funds

provided by the City of Jacksonville in accordance with the provisions of its Procurement/Purchasing Code.

(2) The agreement shall not increase the financial liability of the City of Jacksonville beyond the funds appropriated herein to the City of Neptune Beach.

(3) The City of Jacksonville's payment of funds shall be on a reimbursement basis.

(4) If the year-end financial audit shows an amount less than the total City funding appropriated herein and reimbursed to the City of Neptune Beach is spent, the difference shall be returned to the City of Jacksonville.

Section 5. Oversight Department. The Public Works

Department shall have oversight of the agreement described herein.

Section 6. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
