4 **ORDINANCE 2024-26**

5 AN ORDINANCE APPROPRIATING \$3,500,000.00, FROM  
6 THE GENERAL FUND - FUND BALANCE TO FUND THE CITY  
7 CLOSING FUND GRANT TO FIDELITY NATIONAL  
8 INFORMATION SERVICES, INC., AS PREVIOUSLY  
9 AUTHORIZED BY RESOLUTION 2019-596-A; PROVIDING  
10 AN EFFECTIVE DATE.

12 **BE IT ORDAINED** by the Council of the City of Jacksonville:

13 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
14 within the City's budget, there is hereby appropriated the indicated  
15 sum(s) from the account(s) listed in subsection (a) to the account(s)  
16 listed in subsection (b):

24 The funding above represents an appropriation of  
25 \$3,500,000.00 from the General Fund - Fund Balance to  
26 provide funding for the City Closing Fund Grant to Fidelity  
27 National Information Services, Inc. (the "Company"), as  
28 previously authorized by Resolution 2019-596-A.

29 **Section 2. Purpose.** The purpose of the appropriation in  
30 Section 1 is to fund the "City Closing Fund Grant" in the amount of  
31 \$3,500,000.00 to the Company, as defined in and subject to the terms

1 and conditions of that certain Economic Development Agreement by and  
2 among the City of Jacksonville (the "City"), the Downtown Investment  
3 Authority (the "DIA") and the Company dated October 31, 2019 (the  
4 "Agreement"), as previously authorized by Resolution 2019-596-A. The  
5 Agreement required the Company to complete the construction of a  
6 300,000 square foot office building and structured parking facility,  
7 all as more particularly set forth in the Agreement. The City Closing  
8 Fund Grant will not be disbursed until all conditions to disbursement  
9 have been satisfied under the Agreement and certain other related  
10 agreements by and among the City, the DIA and the Company as  
11 authorized by Ordinance 2019-527-E.

12 **Section 3. Effective Date.** This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
