The appropriation above is a transfer of funding from Subfund 581 - Retained Earnings to Subfund 581 - Self Insured Programs (various) to increase the fiscal year 2020 budget for AFRM - Miscellaneous Insured Programs by \$1,201,843, and to increase the fiscal year 2020 budget for AFRM581AD - Risk Management Administration by \$44,610.

Section 2. Purposes. The purposes of the appropriation in Section 1 are to i) increase by \$1,201,843.00 the fiscal year 2020 budget for AFRM - Miscellaneous Insured Programs by increasing amount for Subobject 04519 - Premium Paid-Property by \$1,144,979.00; increasing the amount for Subobject 04521 - Excess WC Policy by \$5,679.00; increasing the amount for Subobject 04560 -Out of State Auto Liability by \$28,910.00; and, increasing the amount for Subobject 04564 - Excess GL Policy by \$22,275.00; and ii) increase the fiscal year 2020 budget for AFRM581AD - Risk Management Administration by increasing the amount for Subobject 03109 - Professional Services by \$44,610, so as to extend the term of the contract from June 30, 2020, through September 30, 2020, and provide funds for additional maintenance needed for Origami, the new Risk Management System.
