5 A RESOLUTION APPOINTING COUNCIL MEMBER KEN AMARO  
6 AS A MEMBER OF THE NORTHEAST FLORIDA REGIONAL  
7 COUNCIL, AS A COUNTY REPRESENTATIVE AND  
8 DESIGNATED LOCAL COORDINATING BOARD CHAIR,  
9 PURSUANT TO THE APPLICABLE PROVISIONS OF CHAPTER  
10 186, *FLORIDA STATUTES*, AND THE AMENDED AND  
11 RESTATED INTERLOCAL AGREEMENT AUTHORIZED VIA  
12 RESOLUTION 2003-750-A, FOR A TERM ENDING JUNE  
13 30, 2024; REQUESTING ONE-CYCLE EMERGENCY  
14 PASSAGE; PROVIDING AN EFFECTIVE DATE.

17 in accordance with Chapter 186, *Florida Statutes*; and

19 authorized via Resolution 2003-750-A provides for elected  
20 representatives of the governing body of each of the member  
21 governments of the Northeast Florida Regional Council; now therefore

22 **BE IT RESOLVED** by the Council of the City of Jacksonville:

23 **Section 1. Appointment.** The Council hereby appoints  
24 Council Member Ken Amaro to the Northeast Florida Regional Council,  
25 as a county representative and designated Local Coordinating Board  
26 Chair, pursuant to the applicable provisions of Chapter 186, *Florida*  
27 *Statutes*, and the Amended and Restated Interlocal Agreement  
28 authorized via Resolution 2003-750-A, for a term ending June 30,  
29 2024.

30 **Section 2. Requesting One-Cycle Emergency Passage Pursuant**  
31 **to Council Rule 4.901.** One-cycle emergency passage of this

1 legislation is requested. The nature of the emergency is that the  
2 Council would like to seat the appointee in a timely fashion in order  
3 to enable the appointee to participate in the Northeast Florida  
4 Regional Council's upcoming meetings.

5 **Section 3. Effective Date.** This Resolution shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
