4 **ORDINANCE 2024-76**

5 AN ORDINANCE CONFIRMING THE APPOINTMENT OF AMBER  
6 J. SAHBUDAK, AS A MEMBER OF THE PUBLIC SERVICE  
7 GRANT COUNCIL, REPLACING SHERRY JACKSON,  
8 PURSUANT TO SECTION 80.102 (COMPOSITION; MEMBER  
9 QUALIFICATIONS; TERMS; ANNUAL TRAINING  
10 REQUIREMENT; RESPONSIBILITIES), CHAPTER 80  
11 (PUBLIC SERVICE GRANT COUNCIL), *ORDINANCE CODE*,  
12 FOR A PARTIAL TERM TO EXPIRE ON DECEMBER 31,  
13 2024, FOLLOWED BY A FIRST FULL TERM TO EXPIRE ON  
14 DECEMBER 31, 2027; REQUESTING EMERGENCY PASSAGE  
15 UPON INTRODUCTION; WAIVING COUNCIL RULE 4.1101  
16 (APPEARANCE BEFORE COMMITTEE), *COUNCIL RULES*, AS  
17 TO THE REQUIREMENT THAT THE APPOINTEE, PRIOR TO  
18 CONFIRMATION, SHALL APPEAR BEFORE THE COMMITTEE  
19 TO WHICH CONSIDERATION OF THE APPOINTMENT HAS  
20 BEEN REFERRED; PROVIDING AN EFFECTIVE DATE.

21  
22 **WHEREAS**, the Public Service Grant ("PSG") Council has presently  
23 scheduled training for its board members and the initial grant  
24 process, which requires the attention and input of PSG members, will  
25 begin shortly; and

26 **WHEREAS**, PSG Council members are needed to fill vacancies,  
27 appoint PSG officers and begin providing their expertise to the PSG  
28 Council as expeditiously as possible; now therefore

29 **BE IT RESOLVED** by the Council of the City of Jacksonville:

30 **Section 1. Appointment.** The Council hereby confirms the  
31 Mayor's appointment of Amber J. Sahbudak, a Duval County resident,

1 to the Public Service Grant Council, pursuant to Section 80.102  
2 (Composition; Member Qualifications; Terms; Annual Training  
3 Requirement; Responsibilities), Chapter 80 (Public Service Grant  
4 Council), *Ordinance Code*, for a partial term to expire on December  
5 31, 2024, followed by a first full term to expire on December 31,  
6 2027.

7 **Section 2. Requesting Emergency Passage Upon Introduction**  
8 **pursuant to Council Rule 4.901 (Requesting Emergency Passage).**

9 Emergency passage upon introduction of this Ordinance is requested  
10 to enable the appointee to participate in currently scheduled member  
11 training and to participate meaningfully in the time-sensitive  
12 initial grant process which begins imminently.

13 **Section 3. Waiver of Council Rule 4.1101 (Appearance Before**  
14 **Committee), Council Rules.** Council Rule 4.1101 (Appearance Before

15 Committee), *Council Rules*, is hereby waived as to the requirement  
16 that the appointee, prior to confirmation, be required to appear  
17 before the committee to which consideration of the appointment has  
18 been referred in order to facilitate the emergency passage of this  
19 ordinance and maximize participation of PSG Council members in the  
20 grant process.

21 **Section 4. Effective Date.** This Ordinance shall become  
22 effective upon signature by the Mayor or upon becoming effective  
23 without the Mayor's signature.
