6 GENERAL FUND - GSD FUND BALANCE TO FUND CERTAIN  
7 OBLIGATIONS RELATED TO LIFEGUARD DUTIES UNDER  
8 THE CITY'S INTERLOCAL AGREEMENT WITH THE CITY OF  
9 NEPTUNE BEACH, AS AMENDED, AS AUTHORIZED BY  
10 RESOLUTIONS 81-1072-403-A AND 97-1143-A, AS  
11 INITIATED BY B.T. 24-153; PROVIDING AN EFFECTIVE  
12 DATE.

15 **Section 1. Appropriation.** For the 2023-2024 fiscal year,

30 lifeguard expenses under the City's Interlocal Agreement  
31 with the City of Neptune Beach dated May 11, 1982

1 authorized by Resolution 81-1072-403-A, as amended by the  
2 Amendment to 1982 Interlocal Agreement dated February 10,  
3 1998 authorized by Resolution 97-1143-A (the "1998  
4 Amendment").

5 **Section 2. Purpose.** The purpose of the appropriation in  
6 Section 1 is to provide funding to for certain lifeguard expenses  
7 that should have been paid in prior fiscal years pursuant to Section  
8 4 of the 1998 Amendment but were not paid due to a billing oversight  
9 by the City of Neptune Beach.

10 **Section 3. Effective Date.** This Ordinance shall become  
11 effective upon signature by the Mayor or upon becoming effective  
12 without the Mayor's signature.
