5 AN ORDINANCE REGARDING THE GRANT AGREEMENT
6 BETWEEN THE CITY OF JACKSONVILLE AND NORTHSIDE
7 COMMUNITY INVOLVEMENT, INC. ("NCI") FOR THE
8 COMMUNITIES WITH RESOURCES WORKING TOGETHER FOR
9 THE BETTERMENT OF JACKSONVILLE, FLORIDA RE-GRANT
10 PROGRAM (THE "PROGRAM") ORIGINALLY APPROVED AND
11 AUTHORIZED BY ORDINANCE 2025-472-E; AMENDING
12 ORDINANCE 2025-472-E BY AMENDING REVISED EXHIBIT
13 2 (NCI TERM SHEET AND BUDGET) TO REMOVE THE
14 REQUIREMENT THAT APPLICANTS FOR RE-GRANTS
15 THROUGH THE PROGRAM MUST HAVE A PHYSICAL ADDRESS
16 WITHIN COUNCIL DISTRICT 8; REQUESTING ONE CYCLE
17 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

19 **WHEREAS,** on September 23, 2025, the City Council enacted
20 Ordinance 2025-472-E to appropriate \$125,000 to Northside Community
21 Involvement, Inc. ("NCI") for the Communities with Resources Working
22 Together for the Betterment of Jacksonville, Florida Re-Grant Program
23 (the "Program") and authorized execution of a grant agreement with
24 NCI for said Program, subject to the Term Sheet and Budget appended
25 as Revised Exhibit 2 to the enacted legislation; and

26 **WHEREAS,** the Term Sheet required that all applicants for re-
27 grants through the Program must have a physical address within Council
28 District 8; and

29 **WHEREAS,** the District 8 City Council Member desires to allow
30 organizations located throughout Duval County the opportunity to
31 apply for re-grants through the Program and is requesting the City

Council's approval of a revised Term Sheet to effectuate this request;
now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amending Ordinance 2025-472-E to Replace Revised Exhibit 2 (NCI Term Sheet and Budget) as Authorized Herein. Ordinance 2025-472-E, approving and authorizing execution of a grant agreement between the City of Jacksonville and NCI for the Program, is hereby amended to replace the Term Sheet and Budget appended to said legislation with the Term Sheet and Budget attached hereto as **Exhibit 1** and incorporated herein by this reference. The Term Sheet and Budget attached hereto have been revised to remove the requirement that applicants for re-grants through the Program must have a physical address within Council District 8 with all other terms and conditions of the Term Sheet and Budget remaining the same.

Section 2. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that the District 8 City Council Member would like to ensure NCI is able to proceed with the Program, subject to the revised Term Sheet and Budget authorized herein, prior to the end of the calendar year or as soon thereafter as possible.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
