5 AN ORDINANCE APPROPRIATING \$1,471,237.53,
6 INCLUDING \$504,441 IN REVENUE COLLECTED FROM THE
7 FORECLOSURE REGISTRY AND A REALLOCATION OF
8 PREVIOUSLY APPROPRIATED FUNDS IN THE AMOUNT OF
9 \$966,796.53, TO FUND VARIOUS PROGRAMS AND
10 ACTIVITIES AUTHORIZED PURSUANT TO CHAPTER 179,
11 (MORTGAGE FORECLOSURE REGISTRATION), *ORDINANCE*
12 *CODE*, AS INITIATED BY B.T. 27-005; AUTHORIZING
13 POSITIONS, AS INITIATED BY R.C. 27-004;
14 APPROVING AND AUTHORIZING THE MAYOR, OR HER
15 DESIGNEE, AND THE CORPORATION SECRETARY TO
16 EXECUTE AND DELIVER, ANY AND ALL DOCUMENTS
17 RELATED TO THE USE OF FUNDS AUTHORIZED HEREIN;
18 WAIVING THE PROVISIONS OF SECTION 106.303
19 (FORMAT AND DETERMINATION OF AMOUNTS
20 APPROPRIATED), SUBPART A (GENERAL PROVISIONS),
21 PART 3 (APPROPRIATIONS), CHAPTER 106 (BUDGET AND
22 ACCOUNTING CODE), *ORDINANCE CODE*, TO ALLOW
23 MODIFICATION OF THE APPROPRIATION OF FUNDS
24 EXHIBIT TO FACILITATE COMPLIANCE WITH THE
25 REQUIREMENTS OF THE AMERICANS WITH DISABILITIES
26 ACT; PROVIDING AN EFFECTIVE DATE.

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Appropriation.** For the 2026-2027 fiscal year,
30 within the City's budget, there is hereby appropriated the indicated
31 sum(s) from the account(s) listed in subsection (a) to the account(s)

8 (c) Explanation of Appropriation:

9 The funding above comprises \$1,471,237.53, which includes
10 \$504,441 in revenue collected from the Foreclosure Registry
11 and a reallocation of previously appropriated funds in the
12 amount of \$966,796.53, to fund various programs and
13 activities authorized pursuant to Chapter 179 (Mortgage
14 Foreclosure Registration), *Ordinance Code*.

15 **Section 2. Purpose.** The purpose of the appropriation in
16 Section 1 is to provide funding for various programs and activities
17 authorized pursuant to Chapter 179 (Mortgage Foreclosure
18 Registration), *Ordinance Code*. The funds collected are related to
19 real property mortgages that are in default.

20 **Section 3. Approval of Positions.** There are hereby
21 approved the positions more fully described in R.C. 27-004, attached
22 hereto as **Exhibit 2** and incorporated herein by this reference. A copy
23 of the R.C. 27-004 reflecting the Mayor's approval can be found on
24 file with the Budget Office.

25 **Section 4. Approval and Authorization to Execute Documents.**
26 There is hereby approved, and the Mayor, or her designee, and the
27 Corporation Secretary are hereby authorized to execute and deliver
28 any and all documents necessary to effectuate the purpose set forth
29 in Section 2 above.

30 **Section 5. Waiving the Provisions of Section 106.303,**
31 **Ordinance Code.** Section 106.303 (Format and determination of amounts

1 appropriated), Subpart A (General Provisions), Part 3
2 (Appropriations), Chapter 106 (Budget and Accounting Code), Ordinance
3 Code, is hereby waived. This waiver is necessary to allow the
4 modification of the Appropriation of Funds Exhibit to be in the form
5 attached hereto as **Exhibit 1**, in order to facilitate compliance with
6 the requirements of the Americans with Disabilities Act. B.T. 27-005
7 in the form authorized pursuant to Ordinance 2015-428-E and reflecting
8 the Mayor's approval can be found on file with the Budget Office.

9 **Section 6. Effective Date.** This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
