5 AN ORDINANCE APPROPRIATING \$75,000.00 FROM
6 MAYORAL TRANSITION FUNDING WITH THE GENERAL
7 FUND/ GENERAL SERVICE DISTRICT TO PROVIDE
8 FUNDING TO GATEWAY COMMUNITY SERVICE, INC. FOR
9 A CONTRIBUTION FOR A HVAC UNIT AND
10 INSTALLATION AT GATEWAY COMMUNITY SERVICES,
11 INC.; APPROVING, AND AUTHORIZING THE MAYOR, OR
12 HIS DESIGNEE, AND CORPORATION SECRETARY TO
13 EXECUTE AND DELIVER, AN AGREEMENT BETWEEN THE
14 CITY OF JACKSONVILLE AND GATEWAY COMMUNITY
15 SERVICE, INC. FOR A CONTRIBUTION FOR A HVAC
16 UNIT; INVOKING THE EXCEPTION OF 126.107(G)
17 (EXEMPTIONS), CHAPTER 126 (PROCUREMENT CODE),
18 *ORDINANCE CODE*, TO DIRECT CONTRACT WITH
19 GATEWAY COMMUNITY SERVICES, INC.; PROVIDING
20 FOR OVERSIGHT BY THE PUBLIC WORKS DEPARTMENT;
21 PROVIDING AN EFFECTIVE DATE.

23 **BE IT ORDAINED** by the Council of the City of Jacksonville:

24 **Section 1. Appropriation.** For the 2018-2019 fiscal year,
25 within the City's budget, there are hereby appropriated the
26 indicated sum(s) from the account(s) listed in subsection (a) to
27 the account(s) listed in subsection (b):

3 (c) Explanation of Appropriation:

4 The funding above is from Mayoral Transitional Funding
5 within the General Fund/General Service District to
6 provide funding to Gateway Community Services, Inc. for a
7 contribution for a HVAC unit and installation.

8 **Section 2. Purpose.** The purpose of the appropriation in
9 Section 1 above is to provide funding to Gateway Community
10 Services, Inc. for a contribution for a HVAC Unit at Gateway
11 Community Services, Inc. Gateway Community Services, Inc. is on the
12 forefront in the fight against opioid epidemic within Duval County.
13 The HVAC unit will be used in the Administrative Building, which
14 houses the training room and the kitchen, which prepares all meals
15 for the in-house treatment residents.

16 **Section 3. Agreement approved and execution authorized.**
17 There is hereby approved, and the Mayor, or his designee, and
18 Corporation Secretary are hereby authorized to execute and deliver,
19 the Agreement between the City of Jacksonville and Gateway
20 Community Services, Inc., attached hereto as **Exhibit 2**, and
21 incorporated herein by this reference (the "Agreement"). The
22 Agreement provides for \$75,000 for a contribution for a HVAC Unit
23 and installation.

24 **Section 4. Invoking the exception to Section 126.107(g),**
25 **Ordinance Code.** The City is hereby authorized to enter into an
26 agreement with Gateway Community Services, Inc. for a contribution
27 for a HVAC Unit and installation. Pursuant to Section 126.107(g)
28 (Exemptions), Part 1 (General Regulations), Chapter 126,
29 Procurement Code), *Ordinance Code*, such procurement is exempted
30 from competitive solicitation because the supplies or services are
31 to be provided by those specifically prescribed within authorizing

1 legislation that appropriates the same. With the exception of the
2 foregoing, all other provisions of Chapter 126, *Ordinance Code*,
3 shall remain in full force and effect.

4 **Section 5. Oversight.** The Public Works Department
5 shall oversee the project described herein.

6 **Section 6. Effective Date.** This ordinance shall become
7 effective upon signature by the Mayor or upon becoming effective
8 without the Mayor's signature.
