**ORDINANCE 2025-602-E**

AN ORDINANCE APPROPRIATING \$32,000.00 FROM THE  
SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND")  
TO FUND CRIME PREVENTION AND LAW ENFORCEMENT  
EXPENDITURES AND ACTIVITIES INCLUDING: (1)  
TRANSFERRING \$2,000.00 FROM THE FUND TO FLORIDA  
SHERIFFS YOUTH RANCHES, INC., AND (2)  
TRANSFERRING \$30,000.00 FROM THE FUND TO  
DOWNTOWN VISION ALLIANCE, INC. FOR THE HOMEWARD  
BOUND PROGRAM, AS INITIATED BY B.T. 25-105;  
PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE  
SHERIFF'S OFFICE; AUTHORIZING THE MAYOR, OR HER  
DESIGNEE, AND THE CORPORATION SECRETARY TO  
EXECUTE AND DELIVER DOCUMENTS RELATING TO THE  
APPROPRIATION; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1. Appropriation.** For the 2024-2025 fiscal year,  
within the City's budget, there is hereby appropriated the indicated  
sum(s) from the account(s) listed in subsection (a) to the account(s)  
listed in subsection (b):

2 The funding above represents an appropriation of \$32,000  
3 from within the Special Law Enforcement Trust Fund (the  
4 "Fund") to the organizations as set forth herein to support  
5 crime prevention and law enforcement expenditures and  
6 activities.

7 **Section 2. Purpose.** The purpose of the appropriation in  
8 Section 1 is to transfer \$2,000.00 from the Fund to Florida Sheriffs  
9 Youth Ranches, Inc., and transfer \$30,000.00 to Downtown Vision  
10 Alliance, Inc. for the Homeward Bound program. The appropriation  
11 supports crime prevention and law enforcement expenditures and  
12 activities. A Certification from the Jacksonville Sheriff's Office  
13 that the subject appropriation from the Fund complies with Section  
14 932.7055, *Florida Statutes*, is attached hereto as **Exhibit 2** and  
15 incorporated herein by this reference.

16 **Section 3. Execution of Documents.** The Mayor, or her  
17 designee, and the Corporation Secretary are hereby authorized to  
18 execute and deliver any and all documents necessary to effectuate the  
19 purpose set forth in Section 2 above.

20 **Section 4. Oversight.** The Jacksonville Sheriff's Office  
21 shall oversee administration of the projects described herein.

22 **Section 5. Effective Date.** This Ordinance shall become  
23 effective upon signature by the Mayor or upon becoming effective  
24 without the Mayor's signature.
