## ORDINANCE 2024-164

AN ORDINANCE ADOPTING THE CITY COUNCIL'S 1-YEAR STRATEGIC PLAN; SETTING THE CITY COUNCIL'S TOP BUDGET PRIORITIES FOR THE 2024-2025 FISCAL YEAR; ENCOURAGING THE MAYOR TO INCORPORATE THE COUNCIL PRIORITIES INTO THE 2024-2025 BUDGET; WAIVING THE PROVISIONS OF SECTION 106.110 (CITY COUNCIL STRATEGIC PLAN), PART 1 (GENERAL PROVISIONS), CHAPTER 106 (BUDGET AND ACCOUNTING CODE), ORDINANCE CODE, REQUIRING SUBMITTAL OF THE STRATEGIC PLAN WITH CORRESPONDING FUNDING REQUESTS TO CITY ADMINISTRATION NO LATER THAN FEBRUARY 15TH; PROVIDING AN EFFECTIVE DATE.

1. These priorities will benefit the public health, safety and welfare by requesting the Mayor include in her FY 24-25 budget a number of funded initiatives designed to address various needs of the community.
