5 AN ORDINANCE APPROPRIATING \$96,604.98 IN GRANT  
6 FUNDING FROM THE FLORIDA DEPARTMENT OF LAW  
7 ENFORCEMENT FOR THE ONLINE STING OPERATIONS  
8 PROGRAM, AS INITIATED BY B.T. 25-040; PROVIDING  
9 FOR OVERSIGHT BY THE JACKSONVILLE SHERIFF'S  
10 OFFICE; PROVIDING AN EFFECTIVE DATE.

12 **BE IT ORDAINED** by the Council of the City of Jacksonville:

13 **Section 1. Appropriation.** For the 2024-2025 fiscal year,  
14 within the City's budget, there is hereby appropriated the indicated  
15 sum(s) from the account(s) listed in subsection (a) to the account(s)  
16 listed in subsection (b):

23 (c) Explanation of Appropriation:  
24 The funding above represents an appropriation of grant  
25 funds from the Florida Department of Law Enforcement for  
26 the Online Sting Operations Program. The grant period  
27 commenced on July 1, 2024, and continues through June 30,  
28 2025. No local match is required.

29 **Section 2. Purpose.** The purpose of the appropriation in  
30 Section 1 is to utilize grant funding from the Florida Department of  
31 Law Enforcement to purchase computer equipment and supplies needed

1 for online sting operations. A copy of the Agreement for State  
2 Financial Assistance outlining the terms and conditions relative to  
3 the grant and use of the grant funds is attached hereto as **Exhibit 2**  
4 and incorporated herein by this reference.

5 **Section 3. Oversight.** The Jacksonville Sheriff's Office  
6 shall oversee administration of the grant and project described  
7 herein.

8 **Section 4. Effective Date.** This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
