7 ECONOMIC SECURITY (CARES) ACT GRANT FUNDING
8 FROM THE FEDERAL GOVERNMENT, AND \$165,265.00
9 FROM THE CITY'S GENERAL FUND) TO PREVENT,
10 PREPARE FOR, AND RESPOND TO THE CORONAVIRUS AS
11 IT AFFECTS THE 2020 FEDERAL ELECTIONS, AS
12 INITIATED BY B.T. 20-112; APPROVING AND
13 AUTHORIZING THE SUPERVISOR OF ELECTIONS TO
14 EXECUTE AND DELIVER ON BEHALF OF THE CITY THE
15 MEMORANDUM OF AGREEMENT FOR FEDERAL FUNDS -
16 CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY
17 (CARES) ACT BETWEEN THE STATE OF FLORIDA
18 DEPARTMENT OF STATE, DIVISION OF ELECTIONS AND
19 THE SUPERVISOR OF ELECTIONS FOR DUVAL COUNTY,
20 FLORIDA; PROVIDING FOR OVERSIGHT BY THE
21 SUPERVISOR OF ELECTIONS; REQUESTING ONE CYCLE
22 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE
23 DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
27 within the City's budget, there are hereby appropriated the
28 indicated sum(s) from the account(s) listed in subsection (a) to
29 the account(s) listed in subsection (b):

5 (c) Explanation of Appropriation

6 The funding above is an appropriation of Coronavirus Aid,
7 Relief, and Economic Security (CARES) Act grant funds in
8 the amount of \$826,327.00, and an appropriation from the
9 City's General Fund in the amount of \$165,265.00 to
10 prevent, prepare for, and respond to the coronavirus
11 pandemic as it affects the 2020 general election
12 election.

13 **Section 2. Purpose.** The purpose of the appropriation in
14 Section 1 is to to provide funds to be used to prevent, prepare
15 for, and respond to the coronavirus pandeic as it affects the 2020
16 general election.

17 **Section 3. Approval and authorization.** There is hereby
18 approved, and the Supervisor of Elections is hereby authorized to
19 execute and deliver on behalf of the City the Memorandum of
20 Agreement for Federal Funds - Coronavirus Aid, Relief and Economic
21 Security (CARES) Act between the State of Florida Department of
22 State, Division of Elections and the Supervisor of Elections for
23 Duval County, Florida, in substantially the same form placed **ON**
24 **FILE** with the Office of Legislative Services.

25 **Section 4. Oversight.** The Supervisor of Elections
26 shall oversee the project.

27 **Section 5. Requesting one cycle emergency passage**
28 **pursuant to Council Rule 4.901 Emergency.** One cycle emergency
29 passage of this legislation is requested because of the time frame
30 of the upcoming general election.

31 **Section 6. Effective Date.** This ordinance shall become

1 effective upon signature by the Mayor or upon becoming effective
2 without the Mayor's signature.
