20 **BE IT RESOLVED** by the Council of the City of Jacksonville:

21 **Section 1. Confirmation.** The Council hereby confirms the
22 Mayor’s appointment of Melinda B. Powers, a Duval County resident,
23 to the Downtown Investment Authority, having substantial business
24 interests in the Southbank CRA, replacing Craig Anthony Gibbs,
25 pursuant to Subsection 55.107(b) (Board membership; term of office and
26 appointment; removal; vacancies; office-holding), Section 55.107
27 (Downtown Investment Authority Board), Part 1 (Downtown Investment
28 Authority), Chapter 55 (Downtown Investment Authority), *Ordinance*
29 *Code*, for a partial term to expire on June 30, 2024, followed by a
30 first full term to expire on June 30, 2028.

31 **Section 2. Effective Date.** This resolution shall become

1 effective upon signature by the Mayor or upon becoming effective
2 without the Mayor's signature.
